It so happens that we (the "editorial" variety) are personally acquainted with both Charles O. Porter and Edwin Durno, M.D., the opposing candidates for Congress from this district.

We have a liking for both, personally. Each is a "nice guy," affable, intelligent, conscientious, hard-working, dedicated to his own concept of the public good.

But each represents a very different philosophy of government, a different concept of the role of government in human affairs, and a vastly different approach to solving public problems.

AND the time is fast approaching when each voter must make a choice between the two. For one who holds both in esteem, it is a difficult personal decision.

But, aside from the personal aspect, the choice on the basis of which would make the best congressman is less difficult—at least for us.

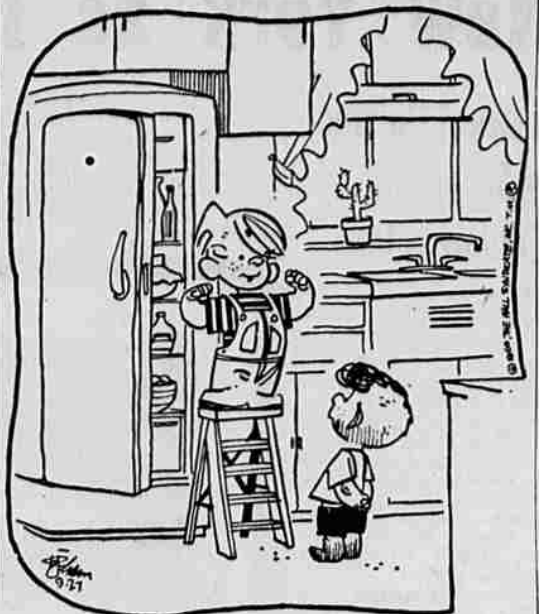
Dr. Durno is an innate conservative. The status quo, with minor modifications, suits him fine. He recognizes some problems which must be dealt with, but believes that a go-slow approach is, almost invariably, the best way to go about it.

Dr. Durno flatly opposes the creation of an Oregon Dunes Seashore, on the ground that it would be a needless waste of federal money, that much of the area is now sufficiently protected for recreational purpose, and that the rest of it should not be closed off from industrial or other development.

Porter supports the Seashore proposal (and in this, incidentally, agrees with the Eisenhower administration where Dr. Durno disagrees), and has worked actively to obtain a workable, fair bill which would set aside this magnificent area for the benefit of Oregonians and their visitors.

DR. DURNO makes much of the "neglect" which the fourth district has suffered at the hands of Congressman Porter, and declares that, if elected, he will work for additional port, harbor, dam and reclamation projects.

30 Years Ago: Gold Hill residents have been directed to boil their water before drinking due to possible contamination of the water supply.

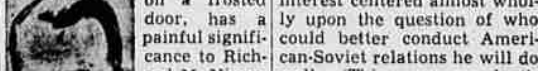
40 Years Ago: Jacksonville is planning to construct its own high school. Fall rains and showers have put the ground here in good shape for fall plowing.

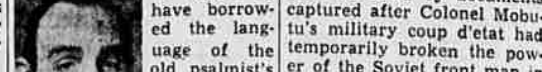
