## St. Mary's High School

## Second Hunter May Be Solution, Court Hears

Dr. Franklin W. Sturges, assistant professor of science at Southern Oregon college, indicated in a letter to the county court last week that a second government hunter might be the better solution to the Compound 1080 poison bait station problem.

Before making a decision, however, Dr. Sturges said he would want to know how extensive the damage by coyotes is, and in what area.

The college professor noted there were "two extreme points of view" at the meeting in the courthouse auditorium Oct. 30. "Both sides went far beyond the facts," he said.

During the meeting, the county court and general public heard Riley Patterson, Roseburg, U.S. fish and wildlife service, explain his proposal to set out at least eight, and not more than 12, coyote poison stations roughly in the Lake Creek area toward the head of Salt Creek. These would be well-advertised,

posted and carefully controlled, he said.

Of the about 50 people attending the public meeting in

the courthouse auditorium, only two men, John Walsh, Lake Creek, and John Niedermeyer, Medford, argued for the poison bait program using Compound 1080. A number of others, led by Mr. and Mrs. Harry Marshall, opposed the program.

## Quoting the Candidates

Sen. John F. Kennedy (Speech televised from Chicago): "I have tried in this campaign to tell the truth to the American people, whether the truth was pleasant or not. I did not reassure the voters that our prestige was at an all-time high... that we were sure to remain first in the world militarily... nor... that we were enjoying 'unprecedented prosperity' because that would not have been true.

"I do not share my opponent's fear of the future — his fears of every new program — his fears that inflation and deficits and unemployment are unavoidable — his fear that we cannot afford what we must afford — or even his fear of a fifth debate."

Vice President Richard M. Nixon (Speeches in Fort Worth, Tex.; Casper, Wyo.; Spokane, Wash.; Fresno,

Calif.): Kennedy's economic promises are "the crudest political hoax ever offered the American people... but the American people are not going to be taken in by this medicine man tactic... a frantic endeavor... to scare the people into voting for" the Democrats.

Opposition Tactics  
"Last minute opposition tactics are becoming more and more desperate. About a week ago, it began to dawn on people that what Kennedy was offering was not a cure for anything, but actually... a slow but sure poison which would destroy the very economic health of our nation."

Kennedy "has continued his misrepresentation of my position time and again when he has told the nation that I am opposed to medical care for the aged.
