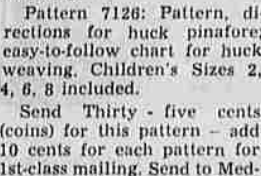
Myles doesn't see this as an imposition on Amy. Our family waits to be invited. But Myles wants open house for his.



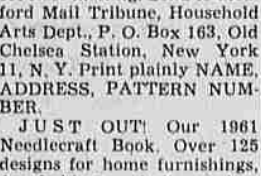

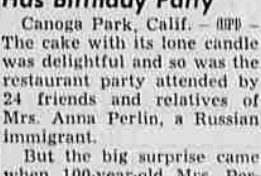
But the big surprise came when 100-year-old Mrs. Perlin announced it was her first birthday party.



Knowland Predicts Test for Kennedy

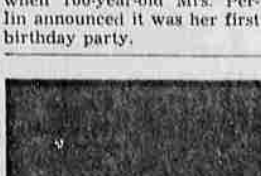
Salem, Ore. - (UPI) - Former U.S. Sen. William F. Knowland predicted Thursday that within eight months the Kremlin will "test" the new Kennedy administration in such trouble spots as Berlin, Far East, Middle East and the Western Hemisphere, including Cuba.

He said the Communists know what the policies of the Eisenhower administration have been but they will probably exert pressure in the areas to see how the policies of President John F. Kennedy differ.



The California Republican said he sees "no indication that the Kennedy administration will yield" but he warned that the next eight months will be challenging times.

Knowland stopped off here after appearing at a GOP luncheon in Portland.

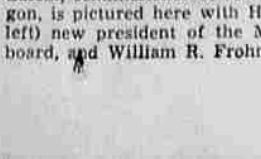
