Congestive Heart Failure

Many people write to say that a relative has been taken to the hospital with "congestive heart failure," and they wonder what these words mean. Will the patient get well, and if so what can usually be done to bring him back to good health? The first thing we must remember is that the heart is a pump which keeps driving our blood around through our body. This blood carries to our cells the much-needed oxygen from the air in our lungs, and it carries to the cells the chemicals they need for food. Naturally, when something goes wrong with the pump, the body suffers.

The heart can fail, long before, in childhood, a valve was injured by rheumatic fever. Perhaps the valve was made too tight so the blood could not get through or it was so nearly destroyed that each time the heart contracted, some of the blood that was pushed out into the big arteries ran back into the heart, and had to be pumped out again. Naturally, that added to the work the heart had to do. Nowadays, expert surgeons are repairing many of these damaged valves and curing the people.

In many other cases, the heart fails a bit because an important branch of one of the coronary arteries which supply the heart with blood, first became narrowed by disease and finally plugged-up tight. Another cause for a weakening of the heart action is a high blood pressure. With this, the heart has to do much more work than it ordinarily does, and eventually the man may begin to be conscious of his laboring heart action.

Breathing Difficult
The first symptoms of a congestive heart failure may be difficulty in breathing. Naturally, this is felt most when the person climbs stairs or walks fast. At night the man may find that he cannot sleep comfortably when lying flat. He sleeps better with three pillows. Also, he may find that after breakfast, when he starts walking against a cold wind, he gets a pain in his chest which makes him stop. Then the pain goes away. This is called "angina pectoris," and it is a danger signal.

Sometimes the man will just get to feeling very tired; also, his ankles may be swollen at night when he gets home. In the morning they look all right again. At times in the night the man may have a spell of something like asthma. Sometimes a woman develops these symptoms when she is pregnant.

Other persons get short of breath when they get too heavy. The extra amount of fat is a big burden that has to be carried around, and this means extra work for the heart. Some small unathletic men and women are carrying around 100 pounds all day. A big athlete would hate to have to do that.

It is wise to recognize heart failure early. It isn't good to wait until one can no longer walk to one's bus. Some people can live fairly comfortably for years with a little heart failure. It helps to go to a good doctor who perhaps can see why the heart has failed, and then can remove much of the cause. Thus, if the blood pressure is dangerously high, it often can be lowered. Also, the person's burden of work at the office may have to be lessened. Naturally, a congestive heart failure, when it comes to a day laborer or a piano mover is a much more serious disease than when it comes to a book-keeper.

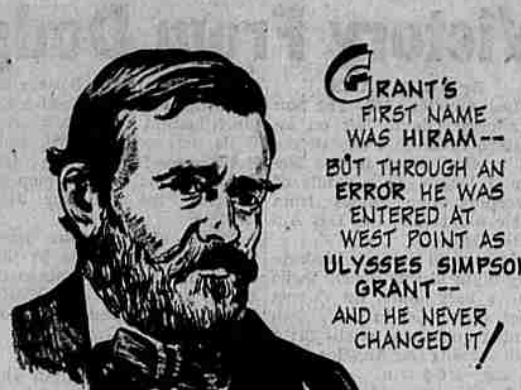
