Gold Hill - Ralph A. James, Sams Valley, was elected permanent chairman for a proposed Youth Center by representatives of several Gold Hill organizations, and interested parents and friends, during a planning meeting held recently at the public library. Gilbert A. Mack, principal of Patrick and Hanby Elementary schools was named by the group to assist James.
