At the end of each statement are the answers to questions asked by the League of Women Voters of Oregon. The questions for county office candidates are:

1. To what special areas pertaining to the office which you seek, do you plan to direct your attention during the next four years?
2. What is your position on the proposed County Home Rule charter and why?

Answers to the questions are numbered according to the question. If no answers appear, the questionnaire was not returned.

Good government starts at the city and county level. At the city and county level, we must keep at a minimum the centralization of power. This centralization of power will destroy us. 3. Extravagant spending of money must be stopped. If we have money to spend, let's spend it so all segments of the county gain benefits. 4. I want to do my part in making Jackson county a good place to live. If elected, I will try to conduct myself as a servant of the people of Jackson county.

At the county level:
1. I am for a well-balanced road program.
2. I am for a well-developed parks and recreation program. Spread the spending so all segments of the people of Jackson county will enjoy recreational activities.

3. Give more O and C money to enhance our school's educational program. Ten percent of O and C money is set aside for schools; we should budget more of the remaining money as tax offset, for schools, thereby the taxpayer would get some relief on their real property tax.

4. I am opposed to the County Home Rule Charter as it is in present form.
Keep In Business
5. I am for keeping the county court in the business of county government.

6. I am for saving the taxpayers' dollar - the county should get a dollar's value for every dollar spent.
I am running for the office of county commissioner for the sole reason of serving the people of Jackson county. I have no sponsoring individual or group. I am not a member of a special interest group. I am paying for and sponsoring my entire campaign. I believe an elected official should be a servant of the people.

Faber's answers to the League of Women Voters questionnaire:
1. The three members of the county court, official head of county government, should conduct themselves as servants of the people. If elected, I will work for a unified cooperative court. Particularly interested in continuing a sound good road program, do what I can to promote relief to the property tax payer. I will work for a sound long ranged recreational and parks program, try and keep the county out of private business. Work for a sound budget.

2. I am opposed to the county Home Rule Charter in its present form. (a) It is a start toward breaking down our two party system. (b) It makes one large unit instead of a court (county) and four departments of government. It would be a more expensive form of government in the years to come. (c) One man paid \$7,200, the others paid \$1,200 or less each with the same responsibility is not good. (d) Election of commissioners is not in the best interest of the people. (Many other reasons.)

3. I attended Willamette university, receiving a BA degree in history and physical education with a minor in biology. After attending summer sessions at Oregon State college and University of California, I received a master degree in education at the University of Southern California. Taught and coached at Ashland High school from 1932 to 1934.

4. From 1936 to 1944, I was associated with Albany college and Lewis and Clark college as professor of health, physical education and recreation. During the war, I was coordinator and director of the Flying School at Ontario, Ore., for Lewis and Clark under contract with the U. S. Navy. Following my discharge I received a year's leave of absence from Lewis and Clark, and during this period re-established myself with my business interests in Jackson county, consisting of Faber's Market and Faber's Farmers Supply.

Sells Interest
I sold my interest in the market in 1959, and since have been a land subdivider, insurance and real estate salesman and specialized in property management.

My participation in civic affairs has been one of my fond interests. I have served two terms as mayor and three terms as councilman of Central Point. Was selected as senior citizen. I am affiliated with Medford Kiwanis club, Central Point Lions club, Central Point Sportsman club, Myers-Holland Post 129 American Legion and CP Volunteer Fire department plus numerous county and local committees for community betterment. I am a member of the Presbyterian church.
