The Smart Cookies 4-H club held their June meeting at the home of their leader, Mrs. Florey.

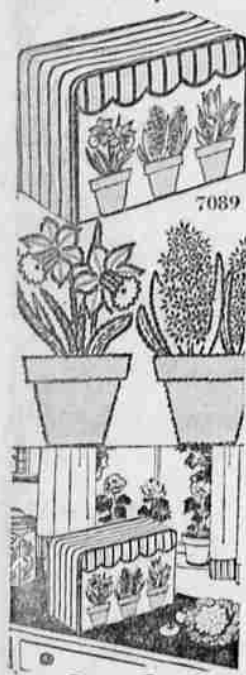
The first year members did a demonstration on brownies while second year members did a muffin demonstration. Members then judged their finished products.
