422,285 Expected In Oregon Schools

Salem--The Oregon Education Department estimated that enrollment in Oregon public schools this fall, an increase of about 10,000 over the previous year.

L. E. Marschat, director of school finance for the department, said this increase is about on a par with the past several years.

The number of Oregon public grade school students in the coming school year was estimated at 402,621 compared to 299,727 last year. The number of public high school students was set at 119,664 compared to last year's 112,469.

To take care of this year's increase, some 440 new classrooms are opening, Marschat said. They were built at a cost of \$16.1 million.

General Strike In Buenos Aires

Buenos Aires -- The CGT Union federation began a 48-hour "general strike" at 12:01 a.m. today, and police mustered a 6,000 man force to deal with any violence.

Scattered bombing attacks on strike-shunning private buses were reported Tuesday and Tuesday night. No one was hurt and damage was minor.

No other violence was reported in the early hours of the strike, but police were supported by radar cars, light planes and helicopters to deal with any disorders that might occur.

The federation is demanding blanket wage increases to offset a 22.5 per cent increase in living costs since Jan. 1.

The strike was expected to close down a good many factories, especially in Buenos Aires' Peronist-dominated industrial suburbs, but consumer services were expected to operate about as usual.

RECORD ENROLLMENT Fort Madison, Ia. -- Approximately 3.4 million boys and girls will enroll in U.S. public and parochial school classrooms for the first time this fall, according to market analyst at Sheffer-Pen company. The analysts said the new enrollment will top all previous figures and bring the number of students to 45.2 million.

Court Refuses Textbook Action

Salem, Ore. - The Oregon Supreme Court Tuesday refused to clarify its stay of mandate in the state textbook case to allow free books to be distributed this coming school year.

The motion asking for clarification was filed by Leo Smith, Portland attorney representing a parent who has children attending a Roman Catholic school in Oregon City.

The motion was denied without comment, and without a written opinion.

This left in force Atty. Gen. Robert Y. Thornton's ruling that the stay allows parochial schools to keep the books they have now, but bars them from getting more books.

The high court last February ruled the law providing free public textbooks to parochial schools unconstitutional. The stay was granted pending outcome of an appeal to the U. S. Supreme Court.

About \$400 in damage to the Perma Products, Inc., plant in White City has been reported to the Jackson county sheriff's office.

Company officials said the plant was entered Sunday night and "someone scattered things around." Chemicals used in making fiber glass products were "dumped together" and solidified, "freezing" the hoses, pumps and other equipment.

A small container, resembling a cash box, also was tampered with, although money wasn't kept in it. A small amount of paint was reported missing.

Al Bounds, owner of the firm, said all of the hoses, resin pumps and guns would either have to be replaced or sent to Belmont, Calif., for repair. Besides the economical loss, there is also the time factor, he noted. He said it would take at least four days to resume operation.

The firm makes fiber glass products such as boats and burial vaults.

39 More Negroes Jailed in Georgia

Albany, Ga. -- The arrest of 39 Negro anti-segregation demonstrators brought to about 300 today the number jailed in racial protests here since July 11.

Tuesday's arrests were made in three separate incidents. A group of 15 Negro teenagers were carried to jail by police early in the afternoon, after they knelt and prayed on the steps of the public library when they were refused permission to enter.

Six Negroes were arrested and jailed after they gathered under the city hall flag pole and began singing hymns.

Eighteen Negroes were arrested after dark when they prayed and sang hymns in front of city hall. Albany Police Chief Laurie Pritchett was scheduled to go on the witness stand for the third time today in an effort to bring a federal court injunction barring racial demonstrations in this troubled south Georgia city.

Humble Abandons Search for Oil

Salem--Humble Oil and Refining Co. Tuesday abandoned its well east of here after drilling 7,800 feet and finding no oil. State Geology Director Hollis Dole announced.

Humble had been drilling for some weeks. The well, which has been plugged, is in the Abiqua creek area near Silverton.

A drilling operation south of here, in the Lebanon area, by Reserve Gas and Oil Co., San Francisco, is continuing, Dole said. He said he believed Reserve planned to drill to 7,500 feet and is at about the 7,000 foot level.

Oil has never been found in commercial quantities in Oregon.

General Strike In Buenos Aires

Buenos Aires -- The CGT Union federation began a 48-hour "general strike" at 12:01 a.m. today, and police mustered a 6,000 man force to deal with any violence.

Scattered bombing attacks on strike-shunning private buses were reported Tuesday and Tuesday night. No one was hurt and damage was minor.

No other violence was reported in the early hours of the strike, but police were supported by radar cars, light planes and helicopters to deal with any disorders that might occur.

The federation is demanding blanket wage increases to offset a 22.5 per cent increase in living costs since Jan. 1.

The strike was expected to close down a good many factories, especially in Buenos Aires' Peronist-dominated industrial suburbs, but consumer services were expected to operate about as usual.</
