## Fifth Sweepstakes Award Is Won By Eugene Bennett

For the fifth time, Eugene Bennett of Medford has been a sweepstakes winner in the annual southern Oregon art exhibit sponsored by the Grants Pass branch, American Association of University Women. The Medford artist won the honor in 1962 for his pole sculpture, "Family Group." The show opened Thursday and continued through Sunday. This is the first time Mr. Bennett has won the sweepstakes award, the other winners having been on paintings. He took top honors in the first show the branch held in 1948, and won the sweepstakes awards at three recent shows. He did not enter the show last year.

His winner in 1959 was a semi-abstract oil entitled "Night Burner," the work having been inspired by the big burners used by sawmills in the area. In 1960 he won the award for an impressionistic oil, "Dusk." Sweepstakes winner in the junior division was Steve Williams, Grants Pass, a student at Southern Oregon college. He entered five oils and watercolors. Judges of the entries, numbering 240, were Mrs. Rachel Griffin and George Johansen, both Portland. Hollis and Harry Marks, Medford, won a red ribbon for an entry entitled "Swan Pow Wow."

came, for they had heard that there had been an accident. Because of the condition of our spare tire, they escorted us 10 miles to the next village. **Border Amazing** The border between Switzerland and France is really amazing. This time, the French didn't stop us and the Swiss only glanced at our passports. They didn't ask us any questions at all. Their money system is very similar to the French, except their franc is worth approximately 23 cents instead of the round number of 20 cents. We are going to find a nice place in the Swiss Alps to relax for a week. We are all very tired from being on the go so much. This week's stay in Switzerland may eliminate Norway and Sweden from our itinerary, but we will go into Bavaria and Austria. Switzerland is full of tourists. We see people in their native dress, from all parts of the world. The area around Lake Lemans is quite a bit like France, but the area we are in now is more like I had pictured Switzerland. Pictures do not do justice to the mountains, for they flatten them out. On Lake Lemans, we had a very lovely "pension" with excellent service. I strongly recommend the Hotel Pension Elisabeth, which is right on the lake. I had a lovely room with balcony overlooking the lake. The customs here are very different. You can lock your door but never take the key with you. Instead, you put it on a hook by your door. In front of the hotel is a walk called Quai des Fleurs. It goes for a long way along the waterfront in front of all the hotels and many private homes. I walked along it and enjoyed the lovely fragrant flower beds that lined the walk. **See Champex** We drove to Champex, had a terrible time finding it. After we got up there we read that you should not attempt to drive unless you are an expert mountain road driver. It was really a climb and we got onto several wrong roads. The area in climate and looks is very similar to Lake of the Woods, except there are more hotels than private homes and no one swims in the lake. There is a separate swimming pool. The lake is used for rowing or fishing only. We did not eat at our hotel, but at the little restaurant nearby. The custom here, as in France, is to serve dinner not earlier than 7 p.m., but we were starved by 6:30 p.m., after spending the afternoon hiking to villages in remote areas. We went to this restaurant and caused quite a stir.

We asked to eat dinner right then. We ordered fondue, a melted cheese dish with kirsch and white wine. The waitress came back and said something to us, that we could not understand. They had someone here who spoke English, so she came to our table, which was on that lake's edge, to a table near a fire pit, then she asked us if we would like to try raclette. We had never heard of it so we asked her what it was. The reason she had asked us to move was so we could watch them make it. **Strange Dish** It was a dish with cheese, potatoes, pickled onion and sweet pickles. Quite a combination. Next they put a dish of the pickles and onions on the table. We could not understand what the waitress was saying, so I asked her if we should eat them now. She said, "No," then started to build a fire in one of the little ovens. We heard her chopping wood in the wood house. Pretty soon she had a nice fire going, then she brought out a kettle full of little new potatoes. She put some in a basket and put them on our table, telling us to peel them. While we peeled them, the chef brought out a huge piece of cheese and cut it in two pieces. He took one piece and put it on a board and put the board right into the fire—the board even caught on fire. Every few minutes he would scrape the cheese, rind and all, on our plates. We were supposed to take a bite of hot cheese, then potato and then pickle. It was very interesting and different. I can't say I liked eating the cheese rind. We are presently in the Valley of Herens. It is very nice here except for the weather. It is still very warm. We have been having thunder storms. The valley is beautiful, but full of tourists. The river is a milky color. There are lots of evergreen trees here, but they are very thin compared to ours.
