Rural Program
Of Action Sought

Portland, Oct. 3.—Some 1,500 men and women from rural areas Tuesday sought a program of action to strengthen their part of America.

The summarizing came at the conclusion of a two-day, seven-state conference on land and people, one of five in the nation sponsored by the U.S. Department of Agriculture.

Delegates from Oregon, Washington, Idaho, California, Arizona, Utah and Nevada expressed general agreement on two points.

They said rural areas are in a period of crisis brought on by science and technology, as evidenced in changed farm practices.

And they said one answer lies in rural area development programs to find new livelihoods for rural areas, as in recreation.

The delegates were told of a number of federal-aid programs available to rural communities.
