930 pages of testimony were taken down. The objectors were given every chance to have their say.

In his decision Chief Justice Samuel B. Epstein of the Superior Court agreed with the recommendation of the Master in Chancery, Mayer Goldberg, who said that most of the points raised by the plaintiffs were "trifling minutiae which cannot change the obvious and inevitable conclusion presented by the defendants' experts; namely that there is a substantial reduction in tooth decay resulting from fluoridation of the domestic water supply to the optimum standard of one part per million. This conclusion is fortified by the plaintiffs' own experts."

The Master in Chancery said that fluoridation is not medication in the generally accepted sense because all that is done is to add to the water the same chemical which ground water naturally contains in a few thousand cities of this land. The final conclusion was that "fluoridation is a reasonable measure which will have a wholesome effect upon the general public health by accomplishing a substantial reduction of dental caries."

This decision, which was reached by a disinterested judge after reviewing six years of testimony, should go far now to clear up the doubts that some puzzled people have had in their mind.

I always say to such people that I think they should do what a scientist like me does, and this is to listen, not so much to violent opponents, but to men like Prof. Frederick Stare of Harvard, whose business it is to know all the facts. The other evening I spent much time with him discussing this subject, and he is strongly in favor of fluoridation.

Lou Gehrig's Disease
I hate to write discouragingly, but I feel I must answer dozens of people who keep writing to ask if there isn't yet some help in sight for patients with amyotrophic lateral sclerosis, often called Lou Gehrig's disease.

Many ask, "Would it pay to mortgage the farm and go on a

trip to a big clinic, or perhaps to one of two of the big medical schools in the East?" It saddens me, but I must keep saying to these people that as yet I have heard of no cure, and I see no sense in anyone's traveling about in search of a treatment.

There are several others of these miserable, nervous diseases that are due to a bad inheritance from some ancestor-diseases such as Huntington's Chorea, cystic fibrosis of the pancreas, cystic kidneys, hemophilia (easy bleeding), and pernicious anemia. In the case of an in-born disease, a cure must always be very difficult to find because the child was born with some organ which is poorly built, or some body tissue that is inclined to break down; or some cells so defective that they fail to make some chemical such as insulin, that is essential to life.

No physician can put in a new pancreas or new kidneys. In the case of diabetes, fortunately, about 1922, two Canadian doctors, named Banting and Best, learned to extract insulin from the pancreas of animals, and thus this is why today even diabetic children with the severest form of the disease can usually be kept alive. When I was a young man, people born with a tendency to pernicious anemia usually soon died; today with the help of Vitamin B12 we keep them alive indefinitely.

Able chemists are now constantly at work, trying to find out what substance is lacking in the body of the person who was born with a tendency to some destructive disease of the nervous system. When they find it, we probably will soon get a drug which will at least control the disease, much as diabetes is controlled. A while ago, for example, almost all boys born with a strong tendency to hemophilia died; but today, with the help of recently gained knowledge about blood clotting, these lads often can be kept alive for years.

If I had a disease like Huntington's Chorea, or Amyotrophic Lateral Sclerosis, I would not want to pass it on to any child of mine; I would not want to have that on my conscience. I get dozens of letters from good women who say that before they knew the danger, they did pass on their weakness to one or two children, and now, because they did this, their mental suffering is almost unbearable. Every time they look at the crippled child, their conscience hurts them. Often I say, "Don't feel that way, because no doctor warned you of the danger you would run if you had children."
