

Aliens Reminded To File Report Forms

Portland — District Director Alfred J. Urbano of the Immigration and Naturalization Service reminds aliens in Oregon that Thursday, Jan. 31, is the deadline for filing address report forms as required under provisions of the 1952 Immigration and Nationality Act.

Urbano said the law requires that every alien, except those having diplomatic status, representatives of certain international organizations and persons admitted temporarily as agricultural laborers, must file the address report during January of each year at the nearest post office of Immigration and Naturalization Service office.

Credit Use by Farmers Expected To Show Increase

Washington—The Agriculture Department economists predict farmers will be using more credit in 1963 than in previous year.

They should, according to the Economic Research Service, because: More land added to farms; additional livestock to herds; stepped-up change-overs from crop to live stock production; increased use of fertilizer, insecticides, and weed killers; more assembly line hog production; increased mechanization of bulk tanks for milk.

ERS said major farm lenders expect loans to farmers will average higher in 1963, continuing the trend. But with the amount of loans up, fewer farmers probably will borrow money this year. The trend reflects the growth in capital needed to operate a farm and the decline in the number of farms.

Interest rates on farm loans may be a little lower this year than in 1962, ERS said. Lenders expect to have ample credit available for farmers in 1963.

Major sources of agricultural credit are private banks, life insurance companies, and government agencies such as the Farmers Home Administration.
