Two Lost as Tug Sinks Off Nanaimo
Nanaimo, B. C. — The Vancouver-based tug Scotch Fir sank in Georgia Strait near here today and two of its three crewmen were reported missing.
The third crewman aboard the vessel, owned by Texada Towing of Vancouver, reached shore in a small boat.
The 35-foot tug was towing a log boom when it sank. Another tug and the Nanaimo harbor vessel searching for the missing men have been joined by a Royal Canadian Air Force Albatross plane.

Walter L. Grow won an honorable award for his limrick "Lastlines." James Leare, Michael Dillon, Walter Townsend and Paul J. Haas won honorable mentions for their entries in serious poetry.

Has also won a cash award as one of the newsmen of the year.
Edward L. Robinson, a former Alaskan operator of a trading post, won a cash award for true experiences and an honorary award for short stories. James R. Jenkin, domiciliary cartoonist, entered the national contests for the first time and won an honorable award in cartooning. William T. Cuddy won an honorary award in the Veterans Voices section of the project.
Sidney Hollingsworth, former Mail Tribune writer, won a cash award for his book review.

Several Awards

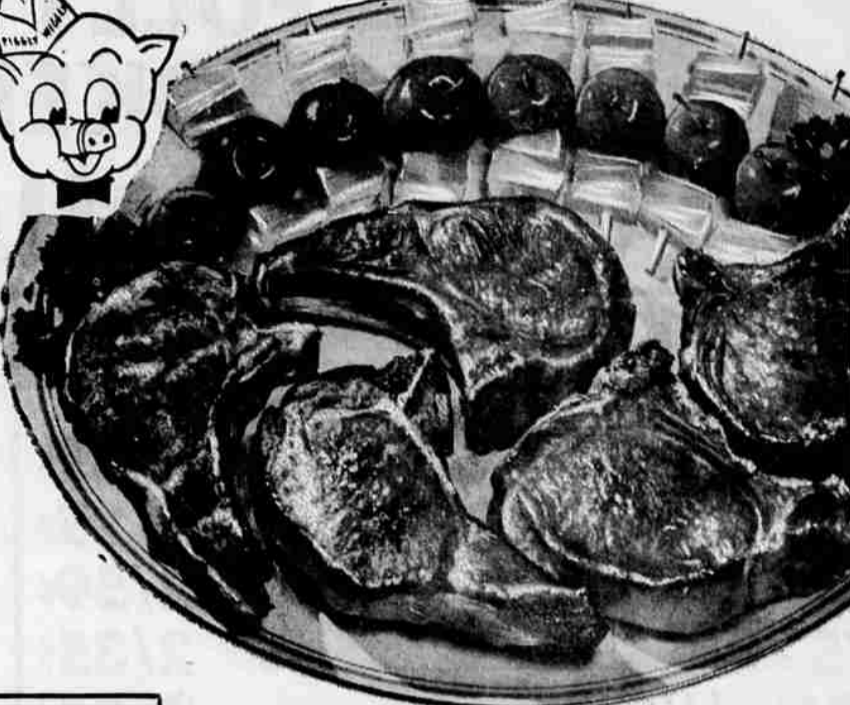
