

### Voting Rights May Face First Test

WASHINGTON (UPI)—A House judiciary subcommittee may take its first test vote today on a key section of President Kennedy's controversial civil rights bill.

Rep. Emanuel Celler (D-N.Y.), chairman of the subcommittee and the parent judiciary committee, said there was a chance the provisions to guarantee voting rights for Negroes could be tentatively cleared at a closed-door session.

The voting rights section ordinarily would be the object of much controversy, but this year arguments about the public accommodations section and the proposed cutoff of federal aid to states practicing discrimination have tended to shield it.

But there still is a great deal of potential conflict in the section, especially in its provisions for temporary voting referees and a legal presumption of literacy for persons who have completed six grades of school.

### Resolution Adopted By Roosevelt League

A resolution urging ratification of the Partial Nuclear Test ban treaty was unanimously passed by the Eleanor Roosevelt League at a meeting at the Public Library of Medford and Jackson County Monday.

Mrs. Harlan Bosworth, who presented the resolution, was authorized to wire copies of the resolution to President Kennedy and to Sens. Wayne Morse and Maurine Neuberger. The ratification bill is now before the senate.

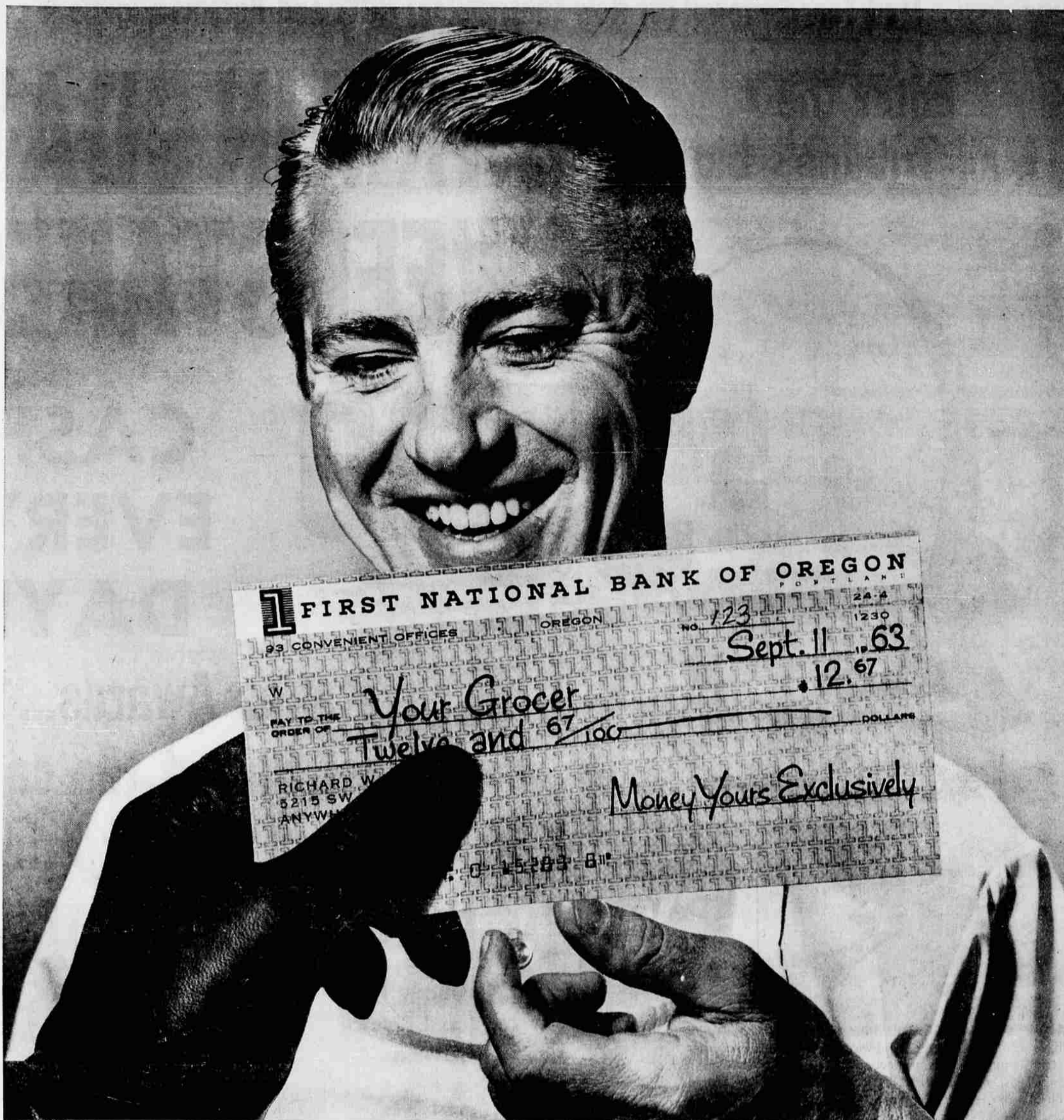
