

Friends of Library Hear Resignation of Mrs. Deaver as Head

The Friends of the Library of Jackson county, at its first fall meeting Monday evening, voted to give \$50 to the library for the purchase of books.

It also heard a letter of resignation from Mrs. Nathan (Jean) Deaver, who has been president of the group, in which she criticized some library activities. The letter was accepted "with regret," Harry Chipman, vice president, conducted the meeting, and named a three-member nominating committee which will report at the annual meeting next month.

The money gift followed the reading of a letter from the trustees of the library requesting such gifts. The letter also is going to other community groups. In part, it says:

"The prime service of a Public Library to its community is through its book supply—books for children, youth and adults.

"Your library is in great need of books, by every index of judgment it lacks books. Compare it to other Oregon libraries, check its books per capita, or search its shelves in your favorite area, and you will see its weaknesses."

The library's book budget for the current year is about \$20,000, of which about half has been spent since the fiscal year started July 1.

Critical of Policies

Mrs. Deaver's letter of resignation was critical of the library's policies and stated, "for that reason, I feel I can function no longer within the membership of the Friends."

It added:

"The particular areas which I question are the poorly timed salary increase for the personnel, the contract with the Josephine county library and the discontinuance of staff calls, on a regular basis, to the county library branches.

"While the salary increase for personnel undoubtedly was desirable, the reaction to its implementation by both the Jackson county court and Jackson county budget committee was not conducive to their acceptance of the library county budget increase. The major portion of the library finances are dependent on the Jackson county court and the Jackson county budget committee's good will, and it was most unfortunate that this wasn't considered to a greater degree, in granting the salary increase.

"Repeatedly it has been stated that shortage of personnel for cataloging is one of the greatest problems of the library. With the Library of Medford and Jackson County considered inadequately financed, until such time as the financing and the personnel are adequate, the Josephine county contract seems unrealistic.

"I know that the librarians from the various branches have regular meetings with the staff at the Medford library, but several of the branches are falling below previous percentages of use, in monthly library reports, so it seems obvious more sup-

PSC President Backs Suspension of Sororities

PORTLAND (UPI)—Portland State College President Bradford Millar Tuesday defended his suspension of six sororities last week by relating new findings of the organization against a pair of Negro students.

Millar said it had been pointed out that 115 girls sought to join sororities and only 72 could be admitted.

"Some 43 others had to be discriminated against—that is, rejected and disappointed.

"The fact is that only four of the 43 had been rejected by all six sororities at the time the college intervened. Two of these were the Negro girls in question," Millar said.

Number of Reasons

Millar reported that the college was also concerned with discrimination against others for a number of reasons.

"There have been questions about discrimination involving Jews, Catholics, Orientals and those with backgrounds of several European countries, as well as Negroes," he said.

He said the sororities in question had not been suspended because they were positively guilty of discrimination, but because they failed to remove all question that their memberships are selected without regard for race, color or creed.

The suspended sororities are Alpha Chi Omega, Alpha Omicron Pi, Alpha Phi, Delta Delta Phi, Delta Zeta and Pi Beta Phi.

Student Conduct Code Adopted at State University

EUGENE—A student conduct code for the University of Oregon was released Monday by University President Arthur S. Flemming.

The code was drafted by a student-faculty committee which worked on the document during the summer.

The code lists violations which vary in severity, but also to the development of ethically sensitive and responsible persons.

"It is believed that these goals can best be achieved through a sound educational program and policies of student conduct that encourage independence and maturity," the code states.

The code lists violations which can result in disciplinary measures, and establishes a Faculty-Student Conduct committee which will be responsible for recommending policies relating to student conduct, for formulating or approving rules and enforcement procedures, for disposing of individual cases which may come before it, and for recommending changes in the student conduct program.

Provides for Court

The code also provides for the establishment of a Student Court and lesser student tribunals which may impose sanctions on cases referred to them.

Secretary of the Faculty-Student Conduct committee is designated as an Associate Dean of Students, to whom all serious violations of the code will be reported and who will refer cases to the Student Court, other student tribunals, or to the Faculty-Student Conduct committee.

Members of the ad hoc committee which drew up the code included: John M. Foskett, professor of sociology who is a past chairman of the Student Discipline committee and was chairman of the ad hoc committee; Chapin D. Clark, associate professor of law; Grace Graham, associate professor of education; Phil Sherburne, senior student from Rainier, Ore., and president of the Associated Students of the University of Oregon; and Bonnie Arai, senior student from Nyssa.

Formal Procedure

The code calls for a formal disciplinary procedure, which would include notification in writing of charges, and the opportunity for accused student to appear with counsel if he desires, before an appropriate committee or tribunal and to appeal the decision. Sanctions authorized range from admonition and warning to permanent expulsion.

In addition to the code, the document also includes provisions for administration of the code through the Associate Dean of Students. Recently appointed to fill this post was Dr. Francis B. Nickerson, who formerly was executive secretary of the High School - College Relations division of the state system of higher education.

Crippled Youngster Turned Into Human Torch by Taunters

SAN FRANCISCO (UPI)—An eight-year-old girl, crippled by polio, was hospitalized Tuesday with painful burns over 40 per cent of her body — the victim of malicious teasing by two schoolmates because she wore braces on her legs.

The victim, Cathryn Reeves, had been the target of taunts from two young boys for several weeks because of the braces. The taunts reached a climax Tuesday when one of the boys tossed a book of flaming matches at her and redged her flower-print dress to ashes.

"She couldn't do anything but stand there and burn," said an ambulance attendant who rushed her to Mission Emergency hospital.

Cathryn was reported in fair condition today while police searched for the two boys, believed to be schoolmates of the injured girl.

The girl's mother, Winona Reeves, told police her daughter had complained for several weeks of harassment by the suspected assailants.

"She had complained that they pulled her hair and knocked her school books out of her arms," Mrs. Reeves said. "And earlier this afternoon Cathryn said they hit her on the head with a lunch pail on her way home from school."

Unable to run

"The girl was out playing when the harassment started again. She told investigators the boys started flicking one match at a time at her. But, she said, she was unable to run away because of her braces."

Finally one of the boys tossed a book of matches and turned her into a human torch.

A neighbor, alerted by the screams of two other young girls, told police, "I looked down the street and saw little Cathryn staggering along, screaming. Her clothes were all burned off. She was burned all over."
