NEW YORK (UPI) — The morning tabloid New York Mirror, with the nation's second largest daily circulation, put out its last edition today ending almost 40 years of publication.

For the same period was just over 900,000. The brief Hearst Corporation announcement placed part of the blame for the paper's shutdown on last winter's 114-day New York City newspaper strike but indicated the paper had faced serious fiscal problems before that.
