Danger of Secret Meetings Noted

United Press International (UPI)—The faculty—and danger—of attempting to hold secret meetings, or barring newsmen from policy sessions of state boards, was graphically illustrated during the first week of the special session.

Last Thursday seven legislators had breakfast with six members of the Board of Higher Education at the Marion Hotel. They held a private discussion of the conflict between the legislature and a higher education.

Everyone involved denied it was a "secret meeting." But the fact remains everyone involved seemed mightily embarrassed when United Press International discovered what was going on.

Was it pure coincidence that the Board of Higher Education held a special "public" meeting just four hours after the secret session broke up?

While the public knows what went on at the "public" meeting, there still is no assurance that agreements were not worked out at the secret conclave.

Then, the following day, members of the governor's staff, legislative leaders, and attorneys for Boeing held a meeting. Newsmen knew they were meeting, but they were denied admission.

Before the meeting broke up, newsmen knew another crisis had developed over the Boardman Space Age Industrial Park, and that the governor was submitting a special message to the legislature.

There appears no logical reason for newsmen to have been barred from the meeting. Certainly nobody expected to be able to keep the Boardman crisis a secret. The problem had to be laid out so the legislature could find an answer.

But because newsmen were barred, there's the unanswered question: Is there another, as yet unannounced, problem with Boardman?

What the legislature does in public business. Higher education gets almost \$40 million a year of taxpayers' money—what the board does is public business.

When legislators and members of higher education's board hold meetings, the public has a right to know what is going on. When they deliberately hold secret meetings, the public has a right to be disturbed.

When the Boardman deal, which already has cost nearly a million dollars, gets into trouble the public has a right to know about it.

Photo Exhibit Is Booked 2½ Years

United Press International The fourth exhibition of Photography in the Fine Arts (PFA-IV) currently touring art museums across the nation, has been booked solid for the next 2½ years.

Ivan Dmitri, the project director, said the reception took far at its New York introduction and in Seattle, Wash., "has been wonderful."

The exhibition of 152 photographs, 66 in color, by 129 photographers tentatively is scheduled to appear in 30 art museums with more expected to be added to the list.

Richard E. Fuller, president and Director of the Seattle Art Museum and President of the Directors of PFA-IV "truly superb, combining the highest technical and aesthetic standards."

The PFA National Advisory Committee selected the exhibition prints from 1,042 photographs previously judged by a number of photographic organizations and authorities. Some of these included the Professional Photographers of America, the National Press Photographers Association, the Photographic Society of America and the Photographic Society of Japan.

Dmitri, a noted photographer, founded PFA in 1959 as a non-profit organization designed to advance the acceptance of photography as a fine art.

"The exhibit should be of interest to all photographers, both amateur and professional, and untold thousands who don't even own a camera but do like to see the finest being offered today."
