## TO ORGANIZE SATURDAY.

The water meeting Wednesday was quite well attended, but it was impossible to organize, for the reason that all the stockholders were not present. The law requires that the first meeting for the purpose of electing directors and perfecting organization be directed in some newspaper in the county for thirty days, unless all the stockholders are present or give their consent in writing to the proceedings, which consent must be filed with the secretary. On this account the meeting for the purpose of organizing and electing directors was postponed until Saturday, November 12th, at 2 o'clock p. m. At that time it is expected every one who has subscribed stock will be present. In the meanwhile the stock books are open and all interested are urged to make haste to come to the GLACIER office and subscribe to the stock. Do not wait for some one to hunt you up, for if interests are lost and you are the person to see to it that you are properly represented. With all preliminary work done this fall, there is no reason why the water should not be made available next spring, or at least in time for sowing clover and alfalfa next summer. One acre of land with water is worth ten acres without it, and the cultivation of the ditch will at least double the value of every acre of land that can be watered by it. Come forward and do your part without having to be run by your neighbors.

HOOD RIVER today offers the best investment for capital in the northwest. Here exceptional lands are rapidly advancing in price, and with the water ditches assured, prices will double. There is not a piece of land in the valley that is not a good investment at present prices, not one that will not pay by increase in value above 50 per cent for the next five years. Our present land owners are most of them land poor, having more than they can cultivate or improve, and for this reason alone lands are offered for sale. Who buys land here in two years from now will pay for it handsomely. Unimproved lands in Riverside, California, so situated as to be irrigated, bring readily \$250 per acre, and we want to say right here that Hood River lands will produce acre for acre as much money as any spot in California, Riverside not excepted. The day is not far distant when there will be but few farms in the valley larger than a quarter of a mile square, and half that will be the average. With water, each twenty-acre tract becomes as valuable as a quarter section without it, and the water in abundance is assured.

Ere we go to press again the election will have taken place and the result will be known. In Oregon the political battle has been a tame one, devoid of enthusiasm and remarkable for bad management, especially on the part of the democrats. Laying political opinions to one side and viewing the matter in an entirely disinterested way, the democrats seem to have much the best of the situation, though, of course, the result cannot be foretold by any one. This is true, if for no other reason that, should the people's party poll enough votes to make it "no election," the lower house of congress would have the deciding voice and place Cleveland in the chair. If this should happen, the senate will have the electing of the vice president, and as the constitution provides that the president and vice president shall not be of the same state, the question as to which body should have the preference would arise, but still Cleveland would have the best of it, as he would be elected first. This would put the senate in a quandary, but it is a dead safe bet Stevenson would not be the vice president.

One of the most amusing phases of the campaign is the sudden and simultaneous discovery by a number of the people's party of republican proclivities that if the democrats stand in and vote with them they are liable to have more votes than they want, and that Weaver might carry Oregon. Making this discovery, they are flipping back into the republican camp. And is compelled to wonder just what they expected to accomplish by voting for Weaver if the promise of a large democratic vote along with their own elections them.

The democracy are slightly demoralized, but are still in the ring. Chairman Harry of the national committee ordered Chairman Murphy to withdraw the presidential electors in Oregon, which Chairman Murphy is not quite large enough to do. He called Butcher, Noland and Colvig to a conference, at which Harry's telegram was read, and it was suggested that the electors withdraw. This they refused to do, and for a time the air was redolent with noise around the democratic headquarters.

Lieutenant Schwartz of Arctic fame was picked up on First street, between Yamhill and Morrison, in Portland, Wednesday morning. An empty lantern bottle by his side explained the situation. He died at 5 o'clock the same morning.

White Justice Bradley has decided that the federal government has a right to supervise federal elections, the rule will not apply to Oregon in that only presidential electors and not congressmen are elected in November. The electors are strictly state officers, and may be elected by the legislature if the state sees fit to so choose them. Hence Uncle Sam cannot interfere.

The fight between Choyinski and Godfrey took place Saturday last, and Godfrey (who is a colored gentleman) was knocked out in the fifteenth round.
