HOOD RIVER, OR., NOV. 25, 1892.

Official returns from Harney and Lake counties cut down Copley's majority over Pierce 232. In fact Copley's plurality is not only wiped out but by the official returns, Pierce now has a plurality of 88 votes, with five counties yet to her from. A telegram from Lake gives Pierce 75 majority, and it may be 175. Pierce's election is conceded to be highly probable by the Oregonian. His election will be contested.

The contract for the remaining 30 miles of the Sunnyside irrigating canal in Yakima county was let last Friday to A. Katz, of Yakima, and John Collins, of Seattle. It is expected that the work will be completed by April 1 of next year. When completed the main canal will be nearly 60 miles long, and there will be nearly 60 miles of laterals in addition. Together with the 30 miles already built, the canal will water about 68,000 acres of the most productive land on earth.

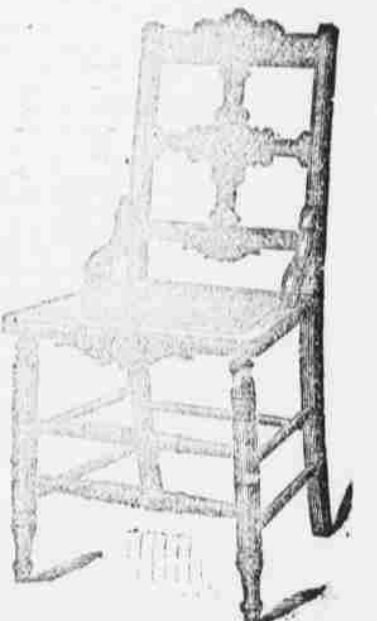
