TREATY ABROGATION CITED AS POSSIBLE

R. E. Scott has received a letter from Chas. H. Babcock, rancher of Maryhill, Wash., who calls the former's attention to a similar organization in the state of Washington, with Frank E. Kanner, of Seattle, as secretary. Mr. Babcock writes that activities of the local organization came to his attention through a reprint of a letter received by Mr. Scott from Senator Chamberlain. Mr. Babcock writes: "Senator Chamberlain is correct in the main, and I know he has no more love for the Oriental laborer than you or I. However, he may have failed to note that it is coming to be recognized that it is not a friendly act on the part of other nations in allowing emigration of persons whom the receiving state does not consider a desirable addition to its population, and an insistence on the part of Japan to a maintenance of the present arrangement under which a large number of laborers—disguised it is true—slip in constantly and which permits the entry of female laborers as so-called picture brides, may well be regarded as an unfriendly act. Of course, none of us desires to have this thing handled in such a manner as to bring about a war, but it must be dealt with sooner or later, and it must be dealt with in the same manner as the Chinese controversy so far as the final result is concerned. In this connection permit me to say: Congress has power to abrogate a treaty, though I think we should take Senator Chamberlain's attitude—that this power should not be exercised save in an emergency. I think I am correct in understanding that the senator does not question the power of congress to abrogate a treaty. If by any chance he may hold to such an opinion, call his attention to the decision of the United States supreme court in the case of Chae Chang Ping vs. Collector of the Port of San Francisco, in which the Chinese Exclusion Act of 1888 was upheld though it overrides a treaty of 1880. In substance the holding of the court was that the right of a country to exclude aliens from its territory is necessary to its independence and that any permission it may have given to aliens to come here is revocable at its pleasure."

SINGLE JURYMEN AGAINST GIBBET

"We the grand jury of Hood River county, in regular session assembled for the November term of court, hereby unequivocally report in favor of a speedy return of capital punishment in the state of Oregon for persons convicted of murder in the first degree and hereby recommend to that effect." Such was the recommendation returned to Circuit Judge Wilson Monday and signed by the following jurymen, representative citizens of Hood River county: Ralph Root, foreman; Al Ruhnke, H. W. Krussow, Frank Dethman, L. H. Arneson and M. O. Boe. The seventh member of the jury, J. R. Norton, declined to sign the report. All Oregon prosecuting attorneys, in poll taken by Walter H. Evans, prosecuting attorney of Multnomah county, with a single exception favor the return of capital punishment. The exception is Attorney Miller, of Josephine county. The following is a paragraph of the Oregonian article telling of Mr. Evans' findings: "Though heartily in accord with the return of the gibbet, A. J. Derby, prosecutor for Hood River county, doubts the wisdom of amending our constitution to conform with the practice in federal jurisdictions, as a jury would often hesitate to recommend hanging where deserved, though on examination they might disavow any prejudice against it."
