THE POMONA GRANGE MEETING HARMONIOUS

Harmony, progress and success marked the first quarterly meeting of the Hood River County Pomona Grange for the year 1924. This meeting was held in the hall of the Pine Grove grange Wednesday, February 6. It was largely attended. Forenoon and afternoon sessions were held and the ladies of the entertaining grange served a bounteous and substantial dinner at the noon hour intermission.

The meeting was decidedly harmonious in proof of the unanimity which the grangers of the valley are exhibiting in thought and action. The project of tax reduction is one of the outstanding problems before the people and the members of Pomona Grange were as of one mind when this important subject was discussed and voted upon. Several resolutions on tax reductions and on conservation of public funds were introduced and discussed and they were passed by unanimous votes. A firm and unanimous stand was also taken on the strict enforcement of all liquor prohibition laws.

In the middle of the consideration of these weighty and important questions the grange gathering paused to pay respect and tribute to the nation's departed war time president, the late Woodrow Wilson. A brief memorial was held and a resolution was unanimously passed expressing the loss that was felt in the passing of the late chief.

The present condition of the American farmer dates from May 18, 1922, when the board of governors and advisors of the 12 federal reserve banks met at Washington, D. C., and decided to call in all the bank loans made to farmers. Several years of prosperity made it possible for the farmer to pay off old debts and mortgages. That did not suit the capitalistic class, for if the farmers were out of debt, the capital class would be deprived of an important market for an investment of their accumulated fortunes. So they passed the word along to the banks throughout the country that all farmer's loans must be called in and settled for the cash. Securities were to be refused, even Liberty bonds were refused as security. As a result of this policy, the farmers were forced to dump their grain, cotton, cattle, fruit, or whatever they had, on the market. The markets broke under that forced policy and that in turn broke the farmers throughout the land, and they have been in that condition ever since. More crops will not now give the needed relief; diversification will not do; cooperation will not help; nothing that the farmer can do will help for the reason that he is at present producing goods below cost. When the farmer has to produce \$200 to produce \$400 worth of goods, he is financially sick. There is not one such case but millions of them today. These ills will not be cured until the control of the nation's banking fraternity and placed in the hands of the United States treasury, where it morally and constitutionally belongs.

Dairy and Food Commissioner Mickle gave a very clear analysis and explanation of the superior food value of milk, butter and cheese, as compared to the milk and butter substitutes that are now being made and sold to the public. He pointed by words and by pictures, how malnutrition, disease and deformities are produced by the use of the various milk and butter substitutes, and how the use of genuine dairy products in turn give health, strength and normal development to the human body. Mr. Mickle's address brought forth a strongly worded resolution to the effect that it is the sentiment of the grangers of this valley that they will withhold their patronage from all merchants who deal in dairy substitutes.

O. P. Yoder of the Pine Grove Grange and J. J. Krumenacher of the Odell Grange were elected to serve as delegate and alternate, respectively, to the state grange convention at The Dalles next June.—Contributed.

LEGION FIRM ON IMMIGRATION BILL

Capt. Geo. R. Wilbur, member of the executive committee of the American Legion, department of Oregon, says he does not believe that the criticism of Secretary of State Hughes, directed at the immigration bill introduced in congress by Representative Johnson, and anti-Asiatic organizations of Oregon, Washington and California of the Pacific coast legionnaires," said Capt. Wilbur, "have gone into this matter of preventing the penetration of Japanese into this country very thoroughly, and their investigations have convinced them that total exclusion is the only solution to the problem. The legion will stand firm in spite of the request of Secretary Hughes. The bill of Representative Johnson was inspired by the legionnaires and anti-Asiatic organizations of the Pacific coast states."

Proposals of the Johnson immigration bill which "single out Japanese immigrants for exclusion" are "inconsistent" with the treaty of 1911 and should be eliminated. Secretary Hughes informed Chairman Johnson of the house immigration committee, in a letter made public last Wednesday at the state department.

"I believe such legislative action would largely undo the work of the Washington conference on limitation of immigration, which so greatly improved our relations with Japan," Mr. Hughes warned Representative Johnson.

As a substitute for the exclusion proposals, the secretary suggested that Japan be placed on the same quota basis as other nations and that the immigrant certificate plan now in the bill to provide for selection abroad be made applicable to Japanese nationals. Active cooperation of the Japanese government in carrying out this plan and also in preventing surreptitious entry of Japanese was to be expected, Mr. Hughes continued.

APPLE SPREAD IS DECLARED TO HIGH

Venice, Calif., Feb. 12, 1924.

Editor Glacier: Just purchased from the grocer of R. and S. Henry a quarter's worth of Red Diamond Hood River apples packed by grower No. 443, retelling at 10 cents per pound. Also saw some Bing Diamonds from grower No. 203. When I consider the amount returned to the growers there and know that these apples are retailing here at from \$4 to \$5 per box it seems to me that some system should be devised to cut several middle men's profits, which would return a reasonable price to the growers and also cut the price to consumers. The retailers are not making too much, as they say they pay \$3.50 per box and I saw a general ration apples in the box numbered 443, which, of course, meant a loss to the grocer.

Mrs. Dumble is to be our guest today and I shall take some interest in showing her these apples and calling attention to the retail price. The difference between consumers' and producers' price amazed me.
