And your committee further recommends
that it require a majority of all the votes
cast in the convention to nominate any
candidate. Respectfully submitted.

AFTERNOON SESSION.
Convention called to order, and the
chair appointed R. N. Snell, C. C. Fergu-
son and C. Grissen, tellers.

On motion of W. D. Fenton, Hon. W.
T. Newcomb, of Tillamook county, was in-
vited to a seat within the bar. Upon ac-
cepting the invitation Mr. Newcomb
pledged the support of the Tillamook
democracy to C. V. Kuykendall, candi-
date for joint representative for Yamhill
and Tillamook counties.

The secretary read the following reso-
lution, which was unanimously adopted:
Whereas: The delegates from the
counties of Yamhill and Tillamook to the
democratic state convention, placed in
nomination as joint representative for the
counties of Yamhill and Tillamook, our
esteemed fellow-citizen, C. V. Kuyken-
dall, therefore be it

Resolved: That the democratic party
of Yamhill county, in convention assem-
bled, and Tillamook county by W. T.
Newcomb, chairman of their central com-
mittee, do hereby ratify and confirm said
nomination of C. V. Kuykendall, and
pledge him the united support of the
democrats of this and Tillamook counties,
at the coming June election.

The chairman called for nominations
