HUGH M. BROOKS.

The murderer of Preller hanged at St. Louis, August 10.

DIED A QUAKING COWARD.

The case of Hugh M. Brooks has caused a large amount of excitement throughout the United States, and as the murderer was hanged Friday, we will give an account of the hanging and a synopsis of the case.

When the death warrant was read to Maxwell at 8 o'clock, Friday, he paled perceptibly and it became evident that he was about to weaken. On the march to the scaffold the knees of the condemned man commenced to tremble, and it appeared that he would collapse. He presented a piteous spectacle. Langraff the man who murdered his sweet heart some time ago in St. Louis, was hanged at the same time and from the same scaffold. The contrast between the bearing of the men white on the march to the scaffold was very marked. Langraff tripped bravely forward and met his death without flinching. When the arms and legs of both men had been bound, they were asked if they had anything to say, and on their replying "no," Maxwell in a scarcely audible tone, the trap was sprung.

Not a muscle moved in the case of Landgraf, while Maxwell's struggles were awful to behold. The rope around his neck had slipped and cut his nose, and a stream of blood courses rapidly down his coat. His eyes were dark and he struggled for fourteen minutes.

BROOKS' CRIME.

The crime for which Brooks, alias Maxwell, paid the extreme penalty of the law Friday morning, was the murder of Charles Arthur Preller at the Southern hotel in St. Louis, April 6, 1885. The acquaintance of the two men began in Liverpool, England, when both were on their way to this country. When they arrived in this country they separated at Boston, Brooks coming to St. Louis as Walter Horatio Lennox Maxwell. A few days later Preller arrived and the two were thereafter almost constantly together.

Preller was last seen alive Sunday afternoon, April 6, in Maxwell's room by a bell boy. Twice that day Maxwell bought a large quantity of chloroform at a drug store near by, telling the druggist that he was using it in an experiment. The next day Maxwell made a number of purchases at various places, spending money very freely, although before he had not appeared to have abundance of cash. Among his purchases was a ticket to San Francisco that he bought over the St. Louis & San Francisco Railroad. Nothing was thought of his sudden departure until on the 14th of April. For several days prior to that date the chambermaids noticed an unpleasant odor coming from 144, and connected it with Maxwell's trunks. On the 14th the smell became so pronounced that the trunks were removed to the lower floor and opened. A body was found which proved to be that of Preller. On the inside of the trunk the card bore the inscription: "So perish all traitors to a great cause."

It was an easy matter to trace Maxwell to San Francisco, and he was arrested himself as T. S. Daugier, a French army officer. April 12th, he sailed for New Zealand in the steamer Sidney. Detectives had been close on his track, and when the steamer arrived Auckland he was arrested and returned to St. Louis. The defense made at the trial was that the death of Preller was accidental, Maxwell having administered chloroform preparatory to an operation he was about to perform. It was, however, presumed he would not be permitted to testify in his own behalf. The most damaging testimony against him was that of Detective Dingfelder, who became his cell mate and confidant. Maxwell secured a confession from him, and he was found guilty and sentenced to be hanged. The history of the many subsequent efforts to secure a new trial or commutation of sentence is still fresh in the public mind.

Maxwell's attorney said till the last, in the hope of receiving a dispatch from the British government which would induce further stay of proceedings. Maxwell received the news of the postponement from 7 to 9 o'clock calmly, sought an expression of great relief was plainly visible on his features.

The crowd on the house tops surrounding the jail yard, where the execution was to take place, remained patiently until the hour of execution. The view was clear and unobstructed from the roofs of dozens of buildings in the vicinity and hundreds of people took advantage of the same. The number of spectators admitted to the jail was unusually small for the first time in the history of St. Louis.

Brooks while waiting his death has been the recipient of much attention from the upper class of people. The young ladies especially have shown him much attention, keeping his cell full of the most beautiful flowers. It is strange that their attention should be wasted on a murderer when so many good young men are around.

A SAD ACCIDENT.

HORACE HAWLEY ACCIDENTALLY SHOT AND KILLED.

A Painful Death.

Monday evening Horace Hawley lived about one mile from McJoy shivering his gun and started for McCoy. He had business at that place and took his gun thinking he might see a grouse while on the road. He reached the town, contacted his business and engaged in conversation with Mrs. Finn and Mr. Davis. They were standing on the porch in front of J. D. Bell's drug store; Mr. Hawley leaning on the muzzle of the gun and standing near the edge of the boards. In some manner the gun slipped over the end of the boards and both hammers striking the boards the gun was discharged and both loads entered the abdomen and passed in an upward direction lodging in his lungs. The accident happened at 6:30 in the evening and after 2 1/2 hours of excruciating pain he passed away. As soon as shot he was taken into the store and put under the influence of chloroform. His father and wife were immediately sent for and arrived shortly after. When his father approached the suffering man he said "I am shot father." And when he saw his wife he said "too bad." "too bad." He talked but very little. The doctors administered anesthetics all the time, knowing it was impossible for him to live, they made the end with as little pain as possible. Mr. Hawley was a married man about 26 years of age. His wife was Miss Emma Smith. They have one child. He was an Odd Fellow being a member of Plum Valley lodge No. 60. He was a very fine young man being held high in the estimation of every one who knew him. Many are the expressions of regret made by his brother Odd Fellows in this city as they are all very well acquainted with him. The body was buried Wednesday at 11 o'clock from the residence of his father at Bethel.

Died.—Andrew S. Steward, aged 34 years, on the 28th July, 1888, at Colfax, Washington territory.

The subject of this notice was a native of Yamhill county Oregon, where he resided from early life until only a few years since. Among the citizens of that county, deceased had a large circle of friends and relatives who deeply sympathize with the immediate family of the deceased. The subject of this notice, was unfortunate in this, that he was the victim of temporary but periodic attacks of insanity. But notwithstanding this owing to his industrious habits during his lucid periods by attention to business he was able to support himself in comfort, and as we are informed has some money and property left.


