THE DEMOCRATIC MEASURES.

The democratic members of the ways and means committee have agreed on the following reduction of duties on woolen manufactures.

"On woolen and worsted yarns, 35 per cent; the rate under the McKinley law is 35 and 40 per cent on woolen or worsted cloths. Shawls, knit fabrics and all fabrics made on knitting machines or frames, and all manufactures of every description made wholly or in part of wool, or worsted, not specially provided for, 40 per cent, but specially provided for, 40 and 50 per cent, according to the value.

"On blankets, hats, woolen flannels for underwear, composed wholly or in part of wool, valued at not more than 50 cents per pound, 25 per cent against a present duty under the McKinley law of 50 per cent ad valorem, and not more than 50 cents, 40 per cent ad valorem, against a present rate of 35 per cent, valued at more than 50 cents per pound, 35 per cent against a present rate of 40 per cent ad valorem. On women's and children's dressgoods, coatings, hunchings and goods of similar description, 35 per cent against a duty under the McKinley bill of 50 per cent. Clothing ready made and articles of wearing apparel of every description, cloaks, dolmans, and other outside garments for ladies and children, 45 per cent against the McKinley rate of 60 per cent. On webbing, gaiters, suspender braces, beltings, bindings, braids, galloons, fringes, gimps cords, cords and tassels, dress trimmings, laces and embroideries, buttons, head nets, 40 per cent ad valorem, against the present rate of 60 per cent. On carpets of all descriptions, druggets, carpetings, mats, rugs, screens, covers, art squares and other portions of carpets and carpetings, not specially provided for, which is placed at 50 per cent under the McKinley law.

In addition to these reductions on ad valorem duties, the committee has decided to remove all the specific duties being the per pound and square yard duties, which under the McKinley law, constitute nearly one-half of the present rate of duty under this proposed new law would be about 36 to 37 per cent as compared with 91 per cent under the present law. Here, now, would be a law in the interests of the masses of the people, the consumers. No man in favor of fair dealing can oppose it.

A CASE OF DONT.

The New York World recently delivered a "lectur" addressed to "Senator Hill." It closed with these words: "The democratic state committee will meet in this city tomorrow under your direction. It will call a state convention to elect delegates to Chicago. It intends to fix upon February 22 as the date of that convention."

You know that we are not your enemy. You know that we have upheld you in every step in your political career. You know with what vigor we supported you for governor in 1884 and again in 1888. You know that we first proposed and advocated your election to the senate against your own inclination. You know that we strengthened you in the recent fight to save the legislature at almost any price. You know, in brief, that there is no political achievement—in a small degree—to our free independent support.

"On the other hand— "We know that you mean to be straightforward and honest. We know that you are daring and farsighted. We know that you are in sympathy with the masses. We know that you are poor. We know that you have never stained the executive power by yielding to greedy corporations and corrupting monopolies. We know that you have won from Mr. Cleveland the much of the party enthusiasm which he possessed in 1884. We know that your control of the state committee is absolute. We know how great must be your temptations to use it absolutely. "But we warn you to beware of this dangerous scheme. "It is wrong. "You are playing with fire. You are forging knives for your enemies. "Governor—don't."

The McKinley bill has faults. Its iniquities come out one by one. The New York World publishes the following letter: "A relative sent me and my brother, boys of thirteen and sixteen years, respectively, as Christmas presents, a suit of clothing, a pair of shoes and a hat each. The cost of same in London was: Clothing, \$80; shoes, two pairs, \$5 and hats \$5; total \$90. The custom charges under the McKinley bill, were: Clothing, 25 pounds, valued \$80, duty 60 per cent and 49 cents per pound, \$59.88; hats valued \$5, duty 35 per cent, 2.75; shoes valued \$50, duty 25 per cent, \$12.50; total charges, \$67.13—just \$13.88 more than the actual cost. As we are boys dependent upon our own exertions to make our way in the world, the payment of such outrageous charges would be a great hardship. I would ask if there is no appeal from the appraisement of the custom house officers. (Sigs. A. MELBORSE, Washington, D. C., Jan. 14. In reply, the World says: "The law provides an appeal from a decision of the collector to the board of general appraisers, and if either party, importer, consignee or collector, is dissatisfied with the decision of the board an appeal may be taken, under certain restrictions and within a defined time, to the courts of the United States. The case is extremely interesting, and very clearly illustrates the tarification of our tariff law. The theory that the foreigner pays the tariff seems to have disappeared in this case, which is not exceptional, as every importer and consignee knows."

Luther Benson, the temperance lecturer will be remembered by a large number of people in this city. In the first place he was a very eloquent speaker and charmed his listeners by the melody of his language. In the second place he thoroughly understood all the phases of a drunkard's life having been one himself. It is with deep regret that we learn that upon the completion of his lecture tour in the west and the Pacific coast he ended it in Indianapolis by a protracted spree. The debauch left him stranded and he was sent to the Springfield asylum for drunkards. This falling from grace does not lower the standard of Mr. Benson as a temperance reformer because he is not a hypocrite. He attempts to practice what he preaches but his appetite for drink is stronger than his will power. It is a greater lesson to people addicted to the vice than the complete reform of Mr. Benson would be.

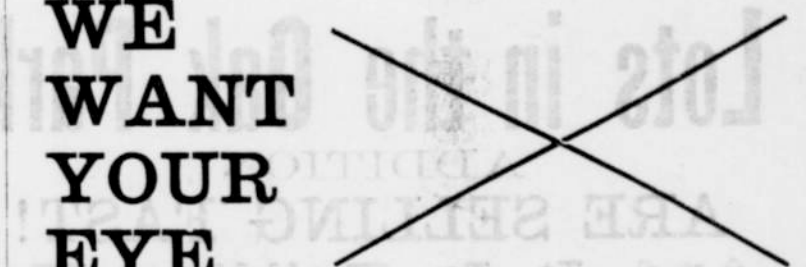
