The agent for the estate of Gen. Ben Butler confirms the report that the estate will conduct a free sanitarium for consumptives at Fort Union, N. M. The estate has \$20,000 acres of land there, and it is proposed to make the sanitarium one of the biggest things of the kind in the country. The only charge to the patients will be for board.

In the inaugural he denounced state extravagance, recommended a constitutional amendment abolishing the clause making the findings of the railroad commission conclusive and also requiring special qualifications for the office. It has been ascertained that the actual shortage which would have been revealed when W. W. Taylor, the defaulting state treasurer of South Dakota, came to transfer his office to his successor, was about \$170,000 in cash. Therefore it is believed he must have appropriated about \$200,000 more when he found out how matters stood, on the theory that he was in for it anyway.
