The wheat was the property of Mr. Hendrick and had been stored for two years. The flour, which consisted of 2,300 sacks, was shipped by Stout & Daniel to Japan. The total shipment was about 100 tons. The Modoc is a large vessel to come up the Yamhill, being about 140 feet long, but made the trip with very little trouble, as the water was quite high. Great care had to be exercised in passing around the locks at Lafayette, to avoid running on to the piling driven there for the temporary dam. The crew of the Modoc is composed of the following obliging gentlemen: Alex Gordon, captain; Jas. Driscoll, engineer; W. M. Smith, purser; Claude Cooper, steward; Miles Lemley, mate; Ira Bell, watchman.
