McKinley does not want a third term, but there is nothing extraordinary in his position. The country is full of men who would be satisfied with two terms.

It is found that the average expenditure of the crowds attending the Pan-American exposition for the month of May was seventeen cents, compared with an average of eighteen cents during the first month of the World's fair.

The Chinese government has ordered that bonds be prepared for the payment of the indemnity of the entire \$337,000,000. Each power is to be liable in the amount of its own claim, which will make the United States bondholder for \$25,000,000. There is nothing to indicate that the United States' claim will be scaled down.

A London paper takes hope because that country still holds the biggest steamships that float. From this it argues that it will be impossible to wrest from Britain its commercial supremacy. But, although Britain has the biggest ships, America has the biggest cargoes. Without the latter there would be no use for big ships. Now that the keen American brains that manage the great railroads of this country have also gone into the ocean-carrying trade, Britain may expect to find her big ships eclipsed. The country that sends the most out will naturally rule the shipping of the world.

California is going it a little too strong when it lynches five men for petty thievery. Yet, when executive clemency is successfully invoked for criminals of every class and degree, not only in California but in every other state of the union, it is no wonder that people lose confidence in the ability of courts of justice to define and punish crime. When they arrive at the conclusion that the governor will release the guilty person anyway, upon the usual recommendation of the judge, jury and district attorney if conviction follows his trial, they are ready to forestall any such action by becoming his own executioners.

What profiteth it a state to make a spectacular discovery of a \$31,000 defalcation, pertinently inquires the Oregonian, years after the crime is outlawed. There would be more point to such a discovery if it were made when it ought to be made, and by those whose duty it is to attend to such matters. This discovery of defalcation is quite as much a revelation of gross carelessness in the administration of important public affairs and of monumental incompetence in examination and verification of public accounts. All of which testifies to the burning desire of the political patriot to serve the dear people for his own benefit.

The friends of Eben Boyce, who is under sentence of death in Seattle for killing his wife, are laying the foundation for a petition for pardon by publishing the statement that Boyce is failing rapidly, losing his mind, staggering as he walks, etc., etc. Of course all this is to be used as a plea for sympathy for the murderer, who should not object to being placed out of reach of his physical and mental troubles by a judicial dose of hanging. There should be no valid objection to hanging such a sick man in view of the fact that the courts of justice have acted without prejudice in his case and performed their duty to society and to the state. The pardoning power is sadly overworked and terribly abused.

Letter From Germany.

Chas. Grissen and family have a letter from their son and brother Carl, now studying to perfect himself on the violin at Stuttgart. He writes under date of May 4th as follows:

Dear Folks at Home—Here it is Saturday and I have not yet written my letter and I usually do so either Tuesday, Wednesday or Thursday.

On Thursday Heilbron and myself went to the Koenigs (King's) parade on the military field at Cannstatt, one of the suburbs of Stuttgart. There were 10,000 troops in the field, infantry, artillery and cavalry. It was an imposing spectacle as they paraded around, and the artillery sounded like thunder as the heavy wagons and cannons rolled by, and the cavalry, each man on his horse holding a flag and perfectly drilled. The king was the commander in chief. The German army is a great and vast organization.

I am digging away in the conservatory and it will not be very long until I am through the second book of the violin and then I will start in the positions and thence will make rapid strides to the master (Singer) and then I shall have my hands full indeed for the lessons must be learned absolutely perfect. Thursday night was the first Prufung concert of the conservatorium. The next will be next Monday.

Frank Lambert, town marshal of the little town of St. Paul, 12 miles east of this city, was shot through the head by John Kelly, at two o'clock Saturday afternoon, during a slight altercation on the street, and as a result Mr. Lambert is lying at his home in St. Paul in a precarious condition, and Kelly occupies a strong cell in the Marion county jail, charged with assault with intent to kill. The two men met on the street, and Kelly, who has the reputation of being a sot, being under the influence of intoxicants, began to abuse the marshal, who is a logger by occupation, for having made use of a private road belonging to J. L. Cook. Lambert and Cook had previously had some words over this matter, and Kelly took up the quarrel. Mr. Lambert argued with Kelly, when the latter became frenzied, and whipping a revolver out of his coat pocket, stated that it was his intention to shoot Lambert. The latter ordered Kelly to put up the pistol then dared him to shoot, and the threat was repeated several times, when Lambert made a spring at Kelly for the purpose of disarming him. At this instant Kelly pulled the trigger, shooting Lambert in the face, the bullet striking him under the left corner of the right eye. Kelly is bound over in the sum of \$1,000. The bullet lodged at the base of Lambert's skull. Frank Lambert, the injured man, is a highly respected citizen of St. Paul, where he has lived for many years. He is about 50 years old, a sober, industrious citizen, and has many friends. He has a wife and a large family of children. Kelly, the would-be murderer, bears the reputation of being a drunkard, and when in his cups is said to be quarrelsome. He is said to have drawn his revolver on numerous occasions and threatened to kill people.
