and says: "Whenever we mention a bit of enterprise upon the part of our Albany friends, it is they who furnish the item. If they were not enterprising we couldn't mention their enterprise. They built a school house for their district school that cost more than \$16,000; they have built a public hall that is a credit to the city; they have secured the railroad bridge and car shops by liberal subscriptions. We don't puff Albany; she don't need it. It is Corvallis we are concerned about.
