EDITORIAL NOTES.

Buffalo Bill, has cleared over \$100,000 with his Wide West show the past year.

William Newman dropped dead at the polls in Chelsea, Mass., while voting. It would be interesting to know what ticket William was voting when he slipped his soul, as those cheerful creatures who see a special providence in every sudden death would be able to rectify their political attitude.

That indefinite compromise between a moldy tradition and a faded reminiscence, James R. Doolittle, of Wisconsin, is trying to break into the fiftieth congress.

Anarchists are still rampant in Europe. In Vienna recently a plot was discovered to destroy the city and assassinate Emperor Francis Joseph. The plans were frustrated by the authorities.

Boston is the subject of a good many sneers for its love of beans, its blue-stocking and spectacled women, its affectation of culture, its grief over the departure of Sullivan and its many other eccentricities, but when Boston women start the reform of checking their bonnets at the theater cloak-rooms, in order to let the audience see something besides millinery, the old town looms up as one which theater-goers generally must fall in love with.

Apart from any question regarding the Monroe doctrine, the completion of the Panama canal would be a gain to commerce and the prosperity of this coast that justifies favorable mention. The opening of that canal would put the Columbia river 9,000 miles nearer New York; it would put London, Liverpool and Havre 14,000 miles nearer to us, and would enable a saving in freight, time, insurance, risk and expense generally of ocean transportation, that would be of mutual benefit and resultant gain.

By the death of Senator Pike, Senator Dolph may become chairman of the committee on claims. At present Mr. Dolph is chairman of the committee on coast defenses, and it is not thought that he will relinquish the chairmanship of that committee to take the place made vacant on the first named committee, which is one of the most important in the senate, but is not likely in the near future to figure so prominently in legislation as the committee on coast defenses.

Nine Randall democrats have been defeated for nomination by their con-

stituencies who disapprove their refusal to consider the Morrison tariff bill. These are Boyle, of Pennsylvania, Ellsberry, Geddes, Warner and LaFevre of Ohio, Henly of California, Iron and St. Martin of Louisiana, and Martin of Alabama. An effort was made by the protectionists to defeat the renomination Blanchard of Louisiana, Scott of Pennsylvania, and Outhwaite and Hill of Ohio, because of their votes in favor of calling up the Morrison bill, but the mass of their democratic constituents sustained them. From which it will be seen that the free trade idea is gaining friends among the democrats.

Mr. Black, in his letter of acceptance to the democrats of Pennsylvania, expresses himself strongly upon the liquor question. "The democratic denial of the right of prohibition," he says, "implies the duty of regulation and though the just power of the state does not extend to the prescription of drink, diet and dress of the individual man, it does extend to the prevention of any abuse of his private right effecting his neighbor or society at large, and I favor the enactment of any law, however stringent, which may be necessary to that purpose, and in any event, the rigid enforcement of those now in existence." Mr. Black is likely to lose some solid democratic votes upon such an issue, even in Pennsylvania.

The American stage is just now conspicuously occupied by the heroes of foreign scandals. Mrs. Langtry has gathered her American dollars in profusion from a well-worked shadow of a scandal with the Prince of Wales and she is here again to repeat the agreeable operation. Miss Cameron is also here with an indignant husband who goes to jail or dogs her about the hotel to keep up a lively scandal, and with a live English lord always kept within the lines of a luscious newspaper story highly seasoned with scandal; and now Miss Fortescue is here, fresh from a spicy breach of promise case with another live English lord. It would seem that the English heroes of the stage believe in a juicy scandal as the best possible recommendation to the American lover of the drama.
