Hon. James McCain had considerable business to attend to at the late Circuit court for Polk county. He was engaged by the prosecution in the case of the State v. Hutchins, indicted for an assault to commit rape, and the cause against J. C. Fletcher, indicted for seduction. Hutchins received four years in the pen., and Fletcher was to be sentenced Saturday.
