IT'S YOUR LAW

Respect for Law Makes Democracy Live

The Skin Diver
Bill was an experienced
skin diver who owned his own
scuba diving equipment.
Pete, a 3-year-old neighbor
boy, was fascinated by skin
diving. He watched all the
TV skin diving shows and
wanted to learn to dive. Bill
finally agreed to let Pete use
his scuba equipment, includ-
ing the air tank and regula-
tor, but charged Pete \$5 for
use of the equipment for a
weekend, since Pete would
use up a tank of oxygen.
After Pete left with the
equipment Bill got worried.
He knew Pete had not had
any diving instructions and
that an inexperienced diver
is subjected to many dangers,
which are frequently not ap-
parent to the diver.
Do you think Bill may be
legal trouble if Pete is hurt
diving?
The answer is that Bill
might be in serious trouble
if the boy should be hurt
while skin diving. There is
not much law on skin diving,
but by applying basic legal
principles it seems probable
that a man in Bill's position
might be found liable if a
youngster is hurt using skin
diving equipment.
Diving with scuba may be
extremely dangerous to an
inexperienced diver, and the
equipment is deceptive since
it does not look dangerous.
Furthermore, the results of
an accident can be very se-
rious, resulting in death or
serious injury.
At the very least Bill owned
Pete the duty of warning
him of the danger involved.
In this case Bill phoned Pete
at the lake where he had
gone and warned the boy not
to use the skin diving equip-
ment until Bill could get
there to show him how to
use it and warn him of the
dangers.
(Oregon lawyers offer this
column as a public service.
No person should apply or in-
terpret any law without the
aid of an attorney who is
completely advised of the
facts involved. Even a slight
variance in fact may change
the application of the law.)
