**Your Social Security**

The voluntary medical insurance premium older people pay for doctor bill insurance under Medicare will go up by 30 cents per month, beginning next July 1. Health, Education, and Welfare Secretary Elliott L. Richardson, announced.

The new premium rate will be \$5.00 per month, up from the current \$5.30.

The increase, Secretary Richardson noted, amounts to only 6 percent compared to a rate increase of 32 percent made last year when the premium was raised by \$1.30 from \$4.00 to \$5.30.

Last year's increase was about double the amount that would have otherwise been required he said because the rate in the previous year had been kept at \$4.00 an amount adequate to finance the program. It was necessary therefore to in effect make two increases at the same time.


Further because the inadequate rate had depleted the trust fund it was necessary last year to provide also for a higher margin for contingencies than is the case this year.

Last year Secretary Richardson said 24 cents (including 2 cents in interest earnings) was planned as a margin for contingencies. A variety of administrative actions have helped to hold down the cost of the program in this past year he said and it has not been necessary to use any of the planned contingency. In fact it is now estimated that the margin over expenditures will turn out to be 26 cents rather than 24 cents.

This is the first time since the Medicare program started he said that program costs for the supplementary medical insurance program have been below the estimates.

With the resulting growth in the trust fund, this year's premium rate can be safely set at a level that allows only 6 cents as a margin for contingencies.
