Register To Vote By October 7

The Marion County Clerk's office said this week that those who wish to vote in the General Election on November 7, must be registered on or before October 7, the final day for registration.

Under Oregon law, voter registration closes 30 days before the election and even though it is Saturday, the Clerk's office is required to be open for registration from 8:30 a. m. to 8:00 in the evening. The Clerk's office is also open for registration from 8:30 to 5:00, Monday through Friday of each week.

As a public convenience, there are 300 deputized registrars scattered throughout the county in all banks, savings and loan offices and some city recorders' offices.

As an additional service for those who cannot get to a registrar during normal working hours, the Election Department of the Clerk's office in the Courthouse in Salem will remain open until 8:00 p.m. on September 29 and October 6, the two final Fridays of registration.

State To Build New Rest Area

GATES — The old Maples Tavern, somewhat in its own right a landmark on the North Santiam Highway (22) approximately two miles East of Gates, is no more. Saturday morning in a controlled practice burn, the Gates Fire Department burned the building preparatory to a planned State Highway Department rest area.

Other buildings on the acquired property by the State Highway Dept. are also slated for removal.

Preparatory to the burning of the building Saturday, the Highway Dept. has already made noticeable improvements in the area.

The Tavern has been closed for several years.

Gates Council Hears Water Report

Thursday, September 21, the Gates City Council held its regular meeting at City Hall. The Council received a report from Tom Wood, a member of the special water committee, on their investigations into the cost of putting a water line to the East end of town and also into the Riverview Park addition. If they are put in, it would be at the cost of the involved property owners.

The report from the Planning Commission notified the Council that one of its members, Walt Rochon, had been unable to attend the last three meetings due to business obligations and will need to be replaced. No replacement has been found yet.

There is a little of the new water system money left and uses for it were discussed with a new pump being mentioned and, also, a cement skirting around the water tank. Costs of these are being looked into.

Hunter Missing Overnight In Snow

SANTIAM PASS—A Cascade Locks hunter missing overnight in the snow-blanketed Clear Lake area about ten miles west of the Pass, walked out to Highway 20 early Saturday morning.

Linn County Sheriff's deputies, who had launched a search at day-break for Stewart R. Lovejoy, about 60, said he reached the highway about 9:00 a.m.

Hunting in the Clear Lake area with a nephew, he had been reported missing Friday evening. Joining in the search were Linn and Lane County Explorer posts and Linn County Search and Rescue coordinators, advisors and members. Deputies said two to three inches of snow covered the Clear Lake area.

Mill City Firm Awarded Contract

DETROIT — John Wills, Wills Shingle Mill, Mill City, was awarded a contract for the removal of salvagable timber collected from Detroit Reservoir, Forester, Mahlon Hale, Detroit Ranger Station, announced this week. The firm bid \$520.00 for the timber.

Some 12 acres of salvagable timber and debris was collected from the Reservoir by the U. S. Forest Service and stored on the flats South of Detroit.

Work began on the removal of the salvagable timber this week and is scheduled for completion in 30 days, Hale said.

The debris will be bunched by a cat preparatory to burning in late November or early December. Some four acres of beached debris along the shoreline will not be burned until the spring, He said.

Work also began this week with cable reinforcement on Santiam and Breitenbush debris collective log booms in Detroit Lake, Hale said.

Forest Service To Have Timber Sale

DETROIT—Sealed bids will be received at the office of Detroit District Ranger Station, up to and not later than 10 a. m., October 12, for an estimated 10,200,000 board feet of Willamette National Forest timber, in the Trappers Butte Leave timber sale. Oral bidding will follow the 10 a. m. opening of the bids.

The sale involves 5,100 MBF of Douglas Fir advertised at \$78.89 per thousand, 5,100 MBF of Western Hemlock and other coniferous species valued at \$46.49 per 1,000 and 256 acres of all species logs priced at \$135.70 per acre, which the bidder is required to purchase. The stand is located approximately 10 miles S. W. of Marion Forks, via Straight Creek Road.

Wolverines Slip By Salem Academy In First League Mix

In a league game Friday, the Santiam Wolverines scored a decisive win over the Salem Academy Crusaders, 20-8. This was Santiam's first league game of the season.

Santiam's first score came in the second quarter with a 2 yard run by Craig Blackburn. Then it was Blackburn again on an 8 yard touchdown. Both point after attempts failed. Salem Academy also scored in the second quarter with a 55 yard pass from Dave Imig to Dave Dunn. The two point conversion run by Don Berger was good. At half time, Santiam held a shakey 12-8 lead.

Santiam's final score came in the last quarter of play on a 6 yard run by Blackburn then David Plotts connected with Gary Taylor on a two point conversion pass.

Craig Blackburn played an outstanding game. Besides scoring all three touchdowns for Santiam, he gained 141

yards rushing on 33 carries. He now has 7 of Santiam's 13 touchdowns this year.

The Wolverines had a total of 176 yards rushing as compared to 95 for Salem. But they had 125 yards passing to Santiam's 48 yards. Santiam had a total of 12 first downs and Salem had 4.

Salem Academy had four fumbles. Matt DeMain recovered one and Dick Gruver picked up three, including one that set up a Wolverine touchdown.

This Friday, Santiam will meet a strong Scio squad here at 8:00 p. m. This will be a league game. So far this year Scio has been unbeaten in three games. They average over 50 points a game and have scored over 60 points in two games.

New Marion Forks Lodge To Be Built

MARION FORKS — With ground already cleared, construction of a new Marion Forks Lodge on the North Santiam Highway will begin within a few days, it was announced here last week.

The old lodge, started originally by Scott and Nancy Young 40 years ago, burned to the ground August 9th.

Rebuilding will be a project of the Youngs, their son and his wife, Robert and Flo Young, and their son-in-law and daughter, Robert and Dorothy Johnson. Completion is due early in 1973.

The new one-story lodge, to be built on the old site and extended on a new fill overlooking Marion Creek, will be 40 by 86 feet, with restaurant, lounge, coffee bar, fireplaces and balcony. It will seat around 150 people, twice that of the old lodge.

Of wood open-beam construction, with shakes and stone, the new lodge also will have expanded parking facilities. Marion Forks is about 16 miles East of Detroit. The cedar and yew trees in which the old lodge nestled were saved.
