## SPECIAL ELECTION NOTICE GATES RURAL FIRE PROTECTION DISTRICT

**ADDITIONAL TAX LEVY NOTICE IS HEREBY GIVEN** that at an adjourned regular meeting of the Board of Directors of Gates Rural Fire Protection District, held March 12, 1973, the said Board adopted an ordinance numbered three (3), calling a special election for the purpose of voting upon the following question set forth in the ballot for said election:

### Measure No. 1 SERIAL TAX LEVY FOR FIRE TRUCK

Shall Ordinance No. 3 of Gates Rural Fire Protection District be adopted to authorize a district property tax of \$2,000.00 per year outside the limitation of Article XI, Section 11, of the state constitution, for five consecutive tax years beginning with 1973-74, to complete financing of a 1970 fire truck bought under lease-purchase agreement in 1971? Taxes levied for such purpose during the five-year period under such ordinance will be \$10,000.00.

If this measure is approved by the legal voters of the district, the tax authorized will be used only in completing the financing of the cost of such fire truck for better fire protection of property within the district. Should a fund balance remain after purchase of such truck, such balance shall be used to meet operating costs of the district.

A complete copy of the aforesaid Ordinance No. 3 is available at the office of the fire district board at Gates, Oregon, and at the offices of the County Clerks of Marion and Linn Counties, Oregon, at Salem and Albany, Oregon, respectively, for public inspection.

Said election will be held on April 18, 1973, and the polls will be open from 2:00 p.m. to 8:00 p.m. on said date.

The polling place will be the Gates City Hall, located at Sorbin Street in the City of Gates, Oregon.
