## Medicare Deductions Explained

"Based on recent telephone calls and visits to the office, we have found that there is a lot of confusion about the deductibles under the two parts of medicare," Charles S. Hall, social security manager in Salem, stated. "The two parts of medicare are entirely separate. It is almost like having two separate insurance policies. Each part has a deductible which must be met before benefits from that part may be made."

"Under part A, the hospital insurance portion of medicare, there is a deductible of \$72 for each benefit period. A person may have more than one benefit period during a calendar year, which means he may be required to pay the \$72 deductible more than once during the year. A new benefit period usually begins when more than sixty days expire between stays in a hospital."

"Under part B, the medical insurance portion of medicare, there is now a deductible of \$60 for each calendar year. Therefore, as soon as a medicare beneficiary's medical expenses go over \$60 for a calendar year this part of medicare will pay 80% of the allowed charges for doctors' and other covered services for the remainder of the year. Any part of this deductible that is met in the last three months of a year may be carried forward to the next year," Hall concluded.

William Tyler Page—1869-1942

"Class, for tomorrow, I want you to write on what you believe should be our American Creed."

"American Creed! What's a creed?" asked William. "What you think Americans should live by," explained Miss Appleby.

Walking home from school, swinging his lunch bucket, he thought about his neighbors, his family, the history of his country, famous people

(Francis Scott Key, Barbara Fritchie) who had lived in his town of Frederick, Maryland. When supper was over, he found his slate and started to write:

"I believe it is my duty to—admire my country study my country try to live by its laws be glad to see its flag waving in the wind defend it when I hear other people finding fault with it."

His family moved to Washington, D.C. One day his father said to him "Bill, how would you like to be a page-boy in the House of Representatives?"

"That I would, What boy wouldn't?" Many years later when he retired from the honored position as Clerk of the House of Representatives at the age of 63, he thought about Miss Appleby and her assignment. What would he say now is an American's Creed?

He started out again: Yes, I believe in the United States of America, as a government of the people, by the people, for the people. Whose just powers are derived from the consent of the governed; a democracy in a republic; a sovereign nation of many sovereign states; a perfect union, one and inseparable; established upon those principles of freedom, equality, justice and humanity for which American patriots sacrificed their lives and fortunes.

I therefore believe it is my duty to my country to love it, to support its constitution, to obey its laws, to respect its

### Turning on a Red Light

Under Oregon law, a steady red traffic light means you must stop. After stopping, you may cautiously turn right without waiting for a green light. You may also turn left after stopping at a red light but only when entering a one-way street.

A turn made on a red light must always be done with caution giving the other traffic the right of way.

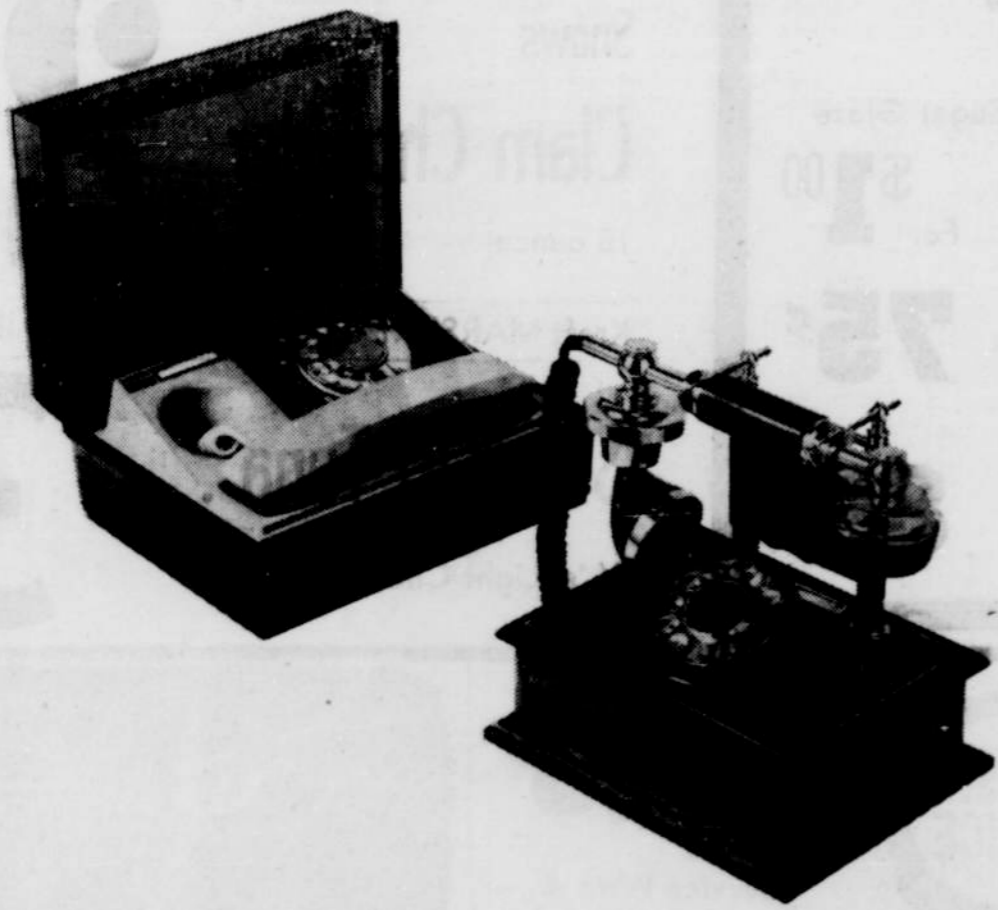
