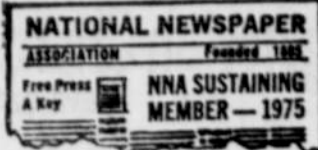

**Four Vehicle Accident Snarles Traffic On 20 & 22**

IDANHA — A four-vehicle accident backed up traffic near Santiam Junction Monday afternoon, hospitalizing two women and injuring a 10-year-old California girl. The two accidents occurred on Highways 20 and 22 about 1 1/2 miles west of Santiam Junction.

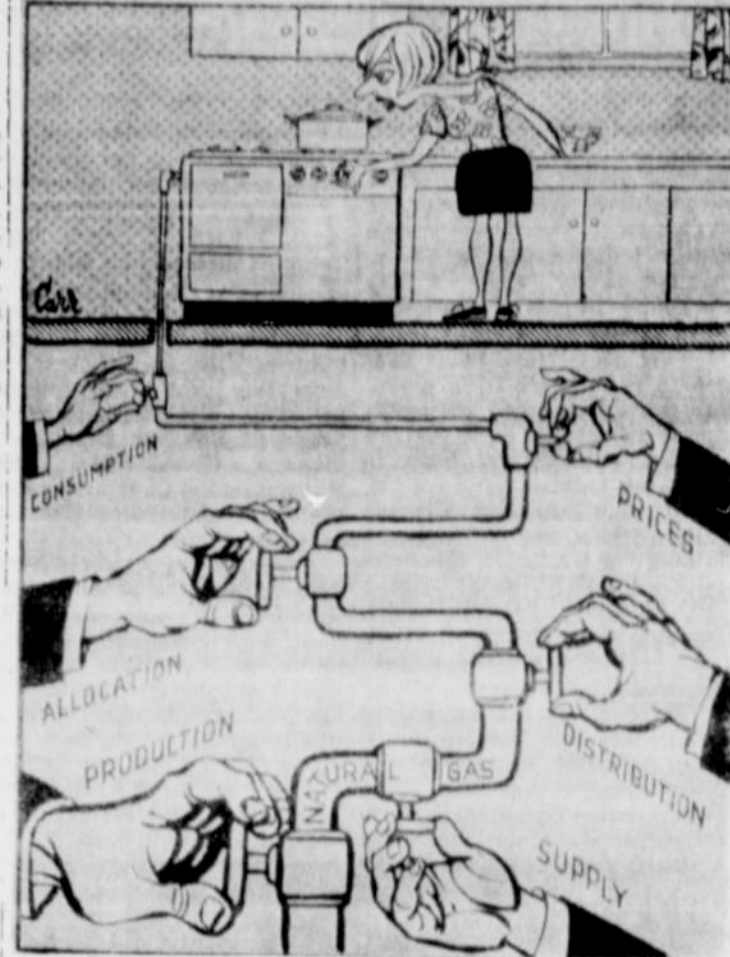
The Idanha Rural Fire District ambulance responded to the accident scene on Highway 22 about 2:20 p. m. Monday, but finding the family with only moderate injuries they were asked by Eugene ambulance to transport a woman victim from the Highway 20 accident to Redmond Hospital.

According to state police, the accident on Highway 22 occurred when a pickup truck pulled out in front of a truck trailer rig that was already passing a line of cars. The pickup clipped the tires of the truck-rig, police said, which flipped the pickup into another pickup truck pulling a travel trailer. The latter vehicle involved a family from Diamond Bar, Calif.

The 1:15 p. m. accident on Highway 20 involved in a trailer house, a pickup and an unloaded logging truck. An unidentified logging truck driver whose brakes reportedly failed crashed into the trailer house demolishing it and then struck a vehicle driven by John Nielson, of Dexter. His wife Lula, about 45, was taken to the Redmond hospital by Idanha Rural Fire District ambulance. She was thrown from the vehicle and sustained chest, back and neck injuries. Ambulance attendants said. The ambulance then returned to the scene of the accident on highway 22, near mile post 87 and transported Lori M. Zava, 10, to Salem Memorial hospital, Emergency Center, for medical attention. She was treated and released. Driver of the other pickup struck by the unloaded logging truck on Highway 20, was Glen Sandell, Lebanon. His wife, Edna, 32, was taken by the Eugene ambulance to a Lebanon hospital.

**'SOMETHING'S WRONG WITH THE GAS.**



**IT'S TIME TO DEREGULATE—**

The domestic natural gas supply situation, serious and worsening, is a prime culprit in increasing United States dependence upon foreign exporters.

In a vicious spiral, over-regulated, artificially low natural gas prices, which stimulate consumption and discourage investment, have led to still more regulation to allocate limited supplies. Many plants, squeezed by regulatory "priorities" rationing reduced reserves, have closed their doors—laying off workers.

Congressional energy proposals seem destined to do more harm than good. None provide the necessary incentive for increasing investments in obtaining new supplies. Nor do they focus upon the real problem of providing more supplies instead of redistributing existing shortages.

To break this senseless circle, it is imperative that users of natural gas demand meaningful deregulation legislation from members of Congress, as part of a comprehensive national energy policy. With prices free to move upward, gas production would be stimulated, demand inhibited and greater use of other energy forms with less finite reserves encouraged.

It is time, once again, to remind our elected representatives that the free market system, allowed to operate without excessive government intervention, best serves America and her people.
