Woe in Lone Star State!

Galveston and Other Cities Nearly Swept Off the Earth--Loss of Life May Reach 10,000 --Loss of Property Millions of Dollars.

A storm struck many cities and towns in Texas on the 8th instant, and left destruction and desolation in its path. Galveston was almost completely wiped off the face of the earth, and what were once the streets were for days running rivers carrying dead bodies to the Gulf. Entire families died together. The loss of life may reach ten thousand, and of property many millions of dollars. Scenes of desolation are on every hand. The scenes presented cannot be told in a prosaic manner. Screaming women, bruised and bleeding, some bearing the lifeless forms of children in their arms; men, broken-hearted and sobbing, bewailing the loss of wives and children; streets filled with floating rubbish and dead bodies, constituted a part of the scene. It was a hurricane, accompanied by a flood, the like of which never was seen.
