NO MORE SUB-LETS.

Special Agent of the Government in Oregon
Looking up Data--Star Route Contractors
Must Carry the Mails in Future.

S. C. Early of Kentucky, postal in-
spector and special agent of the govern-
ment, is in Harney county and will
probably visit Lake at an early date.
Mr. Early is looking up data for the
government relative to the new method
of letting star route mail contracts.
Under the law which goes into effect
in 1903 all who are awarded contracts to
carry the United States mails are com-
pelled to carry them and are not al-
lowed to sub-let. This throws the en-
tire responsibility on the contractor per-
sonally, who is under heavy bonds to do
his duty faithfully. As the matter stood
heretofore the professional star-route
contractor could sit in his office in the
East and send his agent out to the West
to sub-let his western contracts at a
reduced price to some poor man who
thought he could make a living out of
it, and found after hard work and little
pay that he could not faithfully carry
out the provisions of the contract. The
consequence was bad mail service, and
finally throwing up the contract and
placing the responsibility upon the sub-
contractor's local bondsmen. It is a
pleasure to know that in the future all
this trouble and inconvenience will be
done away with, and the man who bids
on contracts will make his bid on a
basis that will insure him a fair re-
compense for his work.
