

**STOCK NOTES
HERE AND THERE**

The following stock notes are taken from the wideawake Yreka Journal:

The meadows and mountain ranges, where the snow has disappeared, have fine crops of grass coming up; in fact, grass is growing nicely under the snow, to afford the best grazing known for many years. The ground has been so well soaked by the great abundance of snow and rain the past winter that the fields will be green nearly all summer, and will not dry out as during most seasons.

A. C. Thormayer, of Sonora, Tuolumne county, who has been in Siskiyou for several days past, purchased a lot of fine large draft horses, paying at the rate of \$150 per head.

Bailey, the United States Government contractor, bought up a large number of horses at Montague the first of this week for cavalry purposes in the Philippines. The prices ranged between \$40 and \$45, for small, sound and active animals, such as are not in demand for other purposes. Several more will probably be purchased in Siskiyou, if the agents cannot secure them in other places where notice has been given out. Contractors can purchase a great many such animals by visiting other parts of the county or giving notice to have them at any given point for acceptance.

New Road Poll Tax Law.

The new road poll tax law requires the collection of \$3 from every male inhabitant over 21 and under 50 years of age, unless by law exempt. The tax may be paid either in labor or cash, but the County Court may require that it be paid in cash. If any person refuses to pay the tax a suit may be brought in a Justice's Court to collect the same, and the wages of the delinquent may be levied upon to collect any judgment recovered.
