

To Lease the King Place.

For the past five years Heryford Bros. have held a lease on this property which only recently again passed into the hands of the owner, N. A. King.

The King property with its four or five hundred cattle is a fine possession even to a lessee, and the lease is covered by many local stockmen. Mr. King says that the two Chewaucan marshes will be drained and that Heryford Bros., King and the Chewaucan Land & Cattle Co. have united in the work. He says there is no good reason why there should not be ten times the amount of hay put up on the two marshes after the draining system, when the entire acreage can be cut over.

Mr. King is at his farm 10 miles below Paisley this week, and himself and party are indulging in some of the old sports; breaking wild horses. He says it's as much fun as ever. When asked if he liked Portland better than Chewaucan, he said he would not stay in Portland one day if it was not for educating his children.

Saving Land to County.

A number of citizens of Prineville and vicinity are taking up homesteads in the timber range near here and thus saving to the county some of the fine land that would otherwise go to some of the outside corporations that are grabbing the timber along the foot of the Cascades, says the Crook County Journal. These corporations do not pay up for the land, consequently they have no perfect title, and therefore do not pay any taxes and so defraud the county to that extent. Had the timber land already located by these concerns, been taken by private individuals it would be taxable as soon as title was acquired, and that could not be put off an indefinite time, thus lessening taxes on the property-owners of the county and making valuable land that now will be held for speculation. We believe that a great deal of the land that is claimed by parties that were in the timber this spring, is held fraudulently and that it is subject to entry by individuals the same as any other timber land.
