

SCHEME FAILS

Attorney General of California Will not be Allowed to Take Leventon, Brown and Eades From Modoc.

The Altura-Plainsdealer puts the laurel wreath upon the brow of District Attorney Bonner in the following beautiful lines: "The scheme of the Attorney General to distribute Leventon, Brown and Eades over the State in sweat boxes for the benefit of head hunters and blood money pirates did not materialize. The fact was due, and all honor we say to him, to the determined attitude of District Attorney Bonner. Beside the enormous cost to the county for such a move Mr. Bonner could find no law to warrant the consummation of such an outrage. The law permits removal to the jail of a contiguous county only where there is no jail, where the jail is unsafe or where there is danger of riot. None of these conditions can be found in the present case, and excuse or palliating circumstances are entirely wanting. We have a six or seven thousand dollar jail and the outrage was only contemplated that the prisoners might be placed at the mercy of the unscrupulous head hunters. That is all there is of it, and it surprises and grieves us that Judge Harrington could not for a moment have thought of lending himself to the consummation of so iniquitous a scheme.

At best, taxes will be high next year in Modoc, and to add to the burden by a still further increase for the benefit of a gang of blood money pirates, would raise such a storm of indignation throughout the county that no one—the Judge or District Attorney would care to face it. The Attorney General and his gang care not a snap of their finger if Modoc county was bankrupted, if only some one—guilty or innocent—could be convicted and blood money won. In common with nine-tenths of the people of Modoc county we hope to hear no more about this scheme. And its defeat is due to Mr. Bonner, and to him the thanks of tax payers are due."

To The Reno Fair.

Secretary Louis Bevier of the Nevada State Fair tells The Examiner that the N-C-O Ry. company has given the Fair committee the lowest passenger railroad rates of any other railroad, and the fact is highly appreciated. Those from this northern country who desire to make that pleasant trip to Nevada's pretty little city can do so for one-half fare from all stations for the round trip.

Traffic Manager J. H. Bennett has issued a circular regarding shipments for exhibition at the Nevada State Fair. These shipments should be forwarded to Reno at regular rates, consigned to the exhibitor, charges prepaid.

Consignors or exhibitors must surrender to the railroad company's agent, when returning shipment, the expense bill showing charges to the Fair, accompanied with certificate of the secretary of the Association, the latter setting forth that property has been on exhibition and not changed hands, when consignment will be forwarded to original shipping point free of charge. The Reno agent will refund all charges for transportation to the Fair, attaching original expense bill, Secretary's certificate and receipt of consignee or exhibitor.

Own Much of the Earth.

The firm of Miller & Lux, California, own 14,534,000 acres of land, nearly all of it unimproved and used for grazing. A considerable portion of the land is located in eastern and southeastern Oregon. Their holdings are equal to the area of New Hampshire, and Massachusetts, Rhode Island and Connecticut together. It is half the size of New York and three times the size of New Jersey; about the size of West Virginia and an eighth of the entire area of California. It is as large as Greece, four times the size of Alsace and Lorraine, and but little smaller than Ireland, and one-third the size of England and Wales together.
