The Lake County Examiner filed a list of bonafide subscribers in Lake county, last Monday, which was duly sworn to and presented to the County Court. The Examiner list showed 627 subscribers in Lake county, and as no other list was presented The Examiner was again designated the County Official Paper. Outside of Lake county The Examiner has 420 subscribers making a total circulation of 1,047, not counting exchanges. The Examiner's circulation in Lake county alone is greater by about 150 than the entire circulation of the average country newspaper. The publishers feel a pardonable pride in The Examiner's biggest of subscribers, which is still growing. There is still room on our books for hundreds more.
