## VACATION DAYS

Are Over Now and the School  
Bell Rings Merrily--Teachers  
--Enrollment--Notes.

The Lakeview public school opened last Monday morning with five teachers and an enrollment of 144 pupils. This is a fairly good attendance for the first day but will be greatly increased during the next few weeks. Several families have moved into town to send their children to school and others will follow soon. The enrollment in the different departments is as follows:

Eighth and ninth grades, J. Q. Willits, principal, 22; sixth and seventh grades, Miss Jessie Sands, 18; fourth and fifth grades, Miss Grace Driver, 41; division A of second, and third grade, Miss Ella Callahan, 29; first, and division B of second grade, Miss Pearl Hall, 34; total 144 pupils.

The present school term opens with exceedingly bright prospects for advancement and progress. The corps of teachers is an excellent one and it behoves parents to assist the teachers in the utmost by keeping their children at school regularly and demanding punctuality in attendance, so that the present term may at least come up to the standard of past seasons in advancement of pupils, if not to surpass any former season in that respect. The life of the teacher is not rose-hued and full of sunshine at the best. It takes stout hearts and indomitable wills, at times, to manage in the schoolroom—there are many aggravating instances in the school teacher's life. Parents can make the teacher's life more pleasant and agreeable, and can assist greatly in school work by laying down certain commandments to be followed by the pupils at home.

All children that will be six years of age by the first day of January next are privileged to enter the school now, so as to avoid the trouble and extra work of starting new classes in the middle of the term.

The Lake County Institute, advertised to have taken place early in the present month, will be held October 24th to 26th inclusive. A number of new teachers will take part in the Institute program.

Miss Gertrude Williams of McMinnville will arrive the last of this week and will go to Adel to take charge of the school at that place.

Miss Mary McNeil, also of McMinnville will arrive with Miss Williams and will teach in Union district, West Side.

Miss Helen M. Bolton of Ashland, will reach here next week and will go to Plush to teach.
