His Bones Bleaching In The Lava Beds.

According to the Redding Searchlight, the man who became a terror to Shasta and Modoc counties as a desperado and who killed a popular officer in the latter county, named Bert Walker, never got out of the famous lava beds. It will be remembered by readers of The Examiner that Ellingsworth and Dorland escaped from the county jail at Redding the sheriff followed them to a lonely place near Adin, and, assisted by Bert Walker, the Alturas constable, who had a record for bravery, took part in duel with the escapees. At that meeting Bert Walker the officer and Dorland the outlaw "passed in their checks."

The Searchlight has evidence from Modoc as follows:

From accounts received from Modoc County it would seem a certainty that Ellingsworth, the outlaw who combated the officers near Lookout, was killed by the Indians after his escape from the encounter. In the mind of S. N. Harvey, constable of Adin, there is no doubt that the bones of the outlaw are now bleaching somewhere on the lava beds of Modoc.

Mr. Harvey was the man who tracked Dorland and Ellingsworth to their camp on the creek. He it was who told the officers of the location of the camp. He was not engaged in the fight, but went in with others and got out Bert Walker, the Alturas constable who was mortally wounded. He heard Walker's story of the encounter.

Asked concerning Ellingsworth, Mr. Harvey said there was no doubt but that he was killed by an Indian. Mr. Harvey says that after the encounter in which Dorland, outlaw, and Walker, officer, were killed, he was one of a party that tracked Ellingsworth for eight days. Finally they lost all track of him, and gave up the chase.

Several days later an Indian whose name Mr. Harvey don't know asked Col. Thompson of the Alturas Plaindealer what there was in it for him to get Ellingsworth. Mr. Thompson told him there was a reward out for the man's capture. He loaned the Indian his rifle to go out after Ellingsworth, cautioning him to order the outlaw to throw up his hands and if Ellingsworth didn't comply to shoot.

A young liveryman of Alturas was present at the conversation. He said: "Tell him now to throw up his hands and when you see him, shoot. He has a good gun and plenty of money, that is enough reward for you."

The Indian went out and was gone several days. When he returned he had over \$100 in money and an Indian friend of his had a new 30-30 rifle such as Ellingsworth is known to have carried.

The deduction that the Indian "got his man" seems reasonable.

Henkle-Ross Nuptials.

Cobb Henkle is recognized as one of Lakeview's confirmed bachelors, not so aged as some people think, and one of the best fellows on earth. It is probably not necessary to say that Mr. Henkle is the proprietor of the swell Alhambra and also of the Irish place down town. Last Saturday morning he skipped the "tralaloo"—or rather tied himself to Nevada's chief town, and—got married. This getting married is not a habit of Mr. Henkle's.

His bride is Anna J. Ross, a lady well known in Lakeview, and who has a kindly heart that other people ought to possess. Mrs. Henkle is esteemed by those who know her best—her good womanly traits of character will make her life-partner happy. 
