Big Irrigation Scheme.

According to the Klamath Falls papers, a large enthusiastic meeting was held at Merrill on Thursday, April 16, in response to a call by the object of the meeting stated.

Upper Klamath Lake, an exhaustless natural reservoir, and irrigate in the neighborhood of 75,000 acres lying south and southeast of Klamath Falls. The total cost of construction is estimated at \$723,000. Digging a cut near the point where the water leaves the lake will cost about \$270,000, its width being one hundred feet and its greatest depth being 130 feet. Another cut, 50 feet in depth, will cost \$75,000. There will be four miles of fluming. requiring seven million feet of lumber nouncement until he has enlightened and costing \$84,000. 
