Fire at Ashland.

A big fire destroyed the larger part of the Fourth-street block between Spring and A streets in Ashland May 18th. The fire spread rapidly and before the fire department responded a large portion of the block was in flames. All of what is known as "The Shack" structures on the street were quickly wrapped in flames and they struck Guernas' brick block with a fierceness that the fire department could not conquer. The block was speedily destroyed, but Guerna saved much of his goods. The flames were mountain high and seen by trainmen ten miles away.

The losses approximately are: Guerna, \$12,000; Mrs. Ganaerds, \$3,000; C. M. Poley, \$1000; Ed Sutton, newspaper man, \$1500; Provost \$1600; McWilliams, \$1200. Other losses are large and will reach \$60,000. Some carried partial insurance. Guerna had no insurance except on the building.

He followed this road to its apparent end and landed in the midst of the big flat near the old Bogne place. The night was extremely dark and every direction he would go he encountered either wire fences or big ditches, or both, till he became tired and his horse weary, so he "put up." He lighted a fire in sagebrush to warm himself, and then it was that the coyotes set up such a howl that cold and darkness was preferable. When daylight came, tired, cold and sleepy he wended his way to the Johnson ranch, where he found food and something for his horse. He reached Paisley at noon.—Post.


