The Examiner is in receipt of a letter from John M. Crawley, traffic manager of the N. C. O. Ry., and in justice to the railroad company we publish. It is self-explanatory.

Dear Sir,—

In a late issue of your paper, you refer to the intentions of merchants in your section shipping by way of Red Bluff instead of via Madeline, and give as a reason that the unreliable information about and delays to freight at Madeline is the cause thereof, from which the reader might infer that the Railroad Co. was responsible, which is not the case. D. W. Earl & Co., are receivers and forwarders of all freight at Madeline, and as such, we, without any delay, turn over consignments to that company, and they are supposed to notify consignees and follow the requests made by them, either to store or deliver, wholly or in part, to teamsters any consignment on any date fixed by the consignee, and they could in other ways, extend accommodation.

In justice to the Nevada-California-Oregon Ry., your readers should understand this.

We have received complaints like unto those outlined by you, and realizing that we will have to suffer for faults not of our own creation, unless a remedy is applied, we therefore intend to see that it is applied, and that our patrons receive proper treatment, not only from the railroad company, but from the forwarders at Madeline.

Chambers Died From His Injury.

As reported in last week's Examiner, William Chambers, who was fatally injured, died as a result. The end came peacefully and painlessly last Saturday morning at 6:30 o'clock. He was conscious up to the last minute, and only realized a few hours before, that he really had to die. He talked very little about himself or any relatives that he might have. He spoke of a sister, Mrs. R. A. Clark, who resides at Napa City, Cal. It was also understood that he had another sister in the east.

The funeral occurred Saturday afternoon, and he was as tenderly laid away as though he was in the hands of his friends and relatives, by citizens who had waited upon him during his sickness, with the assistance of the county. Rev. Smythe came up from New Pine Creek and preached a short and appropriate sermon at the grave.

Should be Watched.

About the hardest looking crowd of Lakeview citizens that have gone out into the mountains, that it has been our displeasure to note, started for Cave Lake last Saturday. Had the posse from Folsom been in the neighborhood of New Pine Creek when this crowd arrived there, they surely would have taken them for the escaped convicts. The crowd were well armed with all kinds of guns and ammunition and no doubt would have put up a hard fight. For identification we submit their names: Frank Light, leader of the gang; Lee Beall, a well known villain; Harry Bailey, been in for four years; Ross Anderson, out for scalps; Max Whittlesy, lost his scalp; Joe Dewey, after molar bears; Wm. Shirk, all around hard case.

Cave Lake is situated about five miles up in the high mountains above New Pine Creek, and can only be reached on foot or horseback. Nevertheless they took along a canvas boat, which they filled with their provisions, guns, ammunition and cold tea. They returned home Monday night and report the scenery about Cave Lake perfectly grand.

C. U. Snider to be Receiver.

C. U. Snider, who returned from Portland Tuesday, came home with the Receivership of the Lakeview land office in his vest pocket. He consulted with the delegation while in the metropolis and they all agreed that Mr. Snider should be appointed. It may be a week or two before the appointment is made, but it is thought that he will be doing duty as Receiver inside of a month.

Mr. Snider is not new to the work of the land office, as he served in the same capacity for four years under President Harrison's administration. No doubt Mr. Snider will give satisfaction to the people of this district and his selection is pronounced a good one.

Motion For New Trial.

Arguments for a new trial in the breach of promise case of Birdie McCarty against J. D. Heryford have been heard by United States District Judge Bellinger, Portland. Miss McCarty sued Heryford for \$75,000 for having trifled with her affections and obtained judgement for \$22,500. The motion for a new trial is based upon an affidavit of Mrs. Fitch, the proprietress of the hotel at Bly, who denies Miss McCarty's statement that she and Heryford stayed at the house and had occupied a single room. Mrs. Fitch declares that the statement is false and also fails to agree with some other portions of Miss McCarty's evidence.
