It is always well to look out for these cheap-John merchants who are either too stingy to advertise their business, or are too trifling, or else they are afraid to invite the public attention to their store for fear it will be found that the statements that they have made in their catalogues and circular letters are untrue. The man that will beat the newspaper will beat you, so beware.

Postmaster-General Payne today declined to uphold the action of Postmaster Baneroff of Portland in summary dismissal of Assistant Postmaster Burkhardt says the Washington correspondent to the Oregonian of May 18th. The effect of the Postmaster-General's action is to procure the re-instatement of Burkhardt. It has been known for some time by the Department that bitter feeling exists between Baneroff and Burkhardt. It became so serious that Baneroff sometime since asked for authority to dismiss his assistant. Investigation showed Baneroff to have been in error, and not the Assistant Postmaster, so this authority was denied.

The Klamath Falls Express has now changed hands and now J. S. Taylor is editor and proprietor. Last week's issue was the first issue under the new management. The new editor starts off with every indication of being a conscientious and upright man. He handles politics fearlessly and without gloves. W. E. Scammon was the first witness to be put on the stand. Only two witnesses were examined and court adjourned until Monday morning.

Monday the remaining witnesses were examined and the case was given to the jury at 6 o'clock.

The jury remained out about 27 hours and could not agree. We understand that it stood for conviction and one for acquittal.

The Examiner learned from Judge Benson that he would not try the case this term.

We learned Tuesday that Marvin Boone met with a painful accident one day last week. While riding a vicious horse, the animal became unmanageable and commenced bucking.
