## Efforts to Convict Benson.

The Government is going to make a determined stand in its attempt to prosecute the principals in the Benson-Hyde Dimond land ring in San Francisco, when the case comes up the middle of the month. Notwithstanding the set-back which the prosecution received by the decision of Judge Lacombe, of New York, who held the indictment failed to charge Berson with any crime against the United States, the Government will insist before the San Francisco court that crime against the General Government is charged and sufficiently shown in the several counts of the indictment.

To strengthen the Government's case, Assistant Attorney-General A. B. Pugh, who worked up the evidence against Benson and others, is at this office if you want to buy, to leave for San Francisco in a few days to be present at the hearing. He will carry with him a copy of Judge Lacombe's decision and a mass of evidence and authorities to show the fallacy of that ruling.

Secretary Hitchcock, it is understood, has instructed the department authorities to use the utmost efforts to have Benson and his associates held for trial, and it is under his instructions that Pugh goes to San Francisco to make what may be the last stand against the land ring. Pugh refuses to discuss bla mission or to comment in any way upon Judge Lacombe's decision .-Oregonlan.




