Carrie Nation's last crusade at Wichita, Kansas, cost her a \$150 fine and 30 days in jail for destruction of property. Three other women who were with her were fined from \$50 to \$150. The sentencing judge said: "Bloodshed will result from these crusades if you are allowed to go unpunished."

The way of a politician was illustrated by senator Dietrich of Nebraska, who was asked by a friend in New York as to how he was getting along. "Well," replied the Nebraskan, "the men whom I gave positions when I was governor still call me governor. Those whom I have helped since I was elected to the senate call me senator. The rest all call me 'that damn ingrate.' I guess I am doing as well as the average."

The remains of Postmaster General Henry C. Payne were laid at rest at Forest Home Cemetery in Milwaukee, Wisconsin, Mr. Payne's home city, on the afternoon of October 19th in the presence of 25,000 persons. Two hundred letter carriers of Milwaukee were in charge of theasket after it was placed in the hearse. Eight letter carriers that were in the service when Mr. Payne was postmaster at Milwaukee acted as pallbearers. The services at the grave were private.

They are telling in London how the Duchess of Devonshire administered a terribly severe snub to a party of army officers who attended a dance at her town house. Among the lot was Guy Wilson, who led in their general policy of what they regarded as dissipated activity. Finally the duchess indignantly approached and said: "Do come and dance with these pretty girls." Gravely bowing, young Wilson said: "Your grace, the Eleventh Hussars do not dance." The duchess flushed slightly and moved away. "Supper was served at midnight and the officers made their way toward the tempting buffets. They were confronted at the entrance by the duchess, who said in determined tones: "Neither do the Eleventh Hussars eat." And neither did they.
